NOTICE IS HEREBY GIVEN that on the 4<sup>th</sup> day of May 2023 the Sheffield City Council made the above Order which comes into operation on the 9<sup>th</sup> day of May 2023 under the provisions of the Road Traffic Regulation Act 1984.

The effect of the Order will be to introduce:

- Off Street Pay and Display parking in West Street Lane Car Park;

And remove:

- Off-Street Pay and Display parking in Carver Street and Wellington Street Car Parks.

Any person who wishes to question the validity of the Order or any of its provisions on the grounds that it is not within the powers of the enabling Act or that a requirement of the enabling Act or any of the relevant regulations made thereunder has not been complied with may, within six weeks of the 9<sup>th</sup> day of May 2023 make application for that purpose to the High Court.

The Sheffield City Council in exercise of its powers under Section 35(1), and Schedule 9 of the Road Traffic Regulation Act 1984 (“the Act”) and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby makes the following Order:-

1. The Sheffield City Council (Off-Street Parking Places) Order 1979 (as amended) shall have effect as though in the Schedule there was included the following items:-
  - a) In the Schedule thereto there were deleted the items ‘Wellington Street’ and ‘Carver Street.
