(AMENDMENT NO. 160) ORDER 2023

NOTICE IS HEREBY GIVEN that on the 20th day of July, 2023 the Sheffield City Council made the above Orders which come into operation on the 24th day of July, 2023 under the provisions of the Road Traffic Regulation Act 1984.

The effect of the Orders will be to introduce:

- Disabled Persons Only Parking Bays on parts of Fulwood Road Service Road, Spooner Road and Taptonville Road;

And remove:

- Pay and Display Parking Bays on parts of Fulwood Road Service Road, Spooner Road and Taptonville Road;
- Disabled Persons Only Bays Mon- Sat 8.00am to 6.30pm on part of Fulwood Road Service Road;

A copy of the Order may be examined during normal opening hours at First Point Reception, Howden House, 1 Union Street, Sheffield, S1 2SH or within the **Sealed Traffic Orders** section on the Council website at <https://www.sheffield.gov.uk/home/roads-pavements/traffic-orders>

Any person who wishes to question the validity of the Order or any of its provisions on the grounds that it is not within the powers of the enabling Act or that a requirement of the enabling Act or any of the relevant regulations made thereunder has not been complied with may, within six weeks of the 20th day of July 2023 make application for that purpose to the High Court.

The Sheffield City Council in exercise of its powers under Section 9 and Schedule 9 of the Road Traffic Regulation Act 1984 (“The Act”) and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby makes the following Order:-

1. The Sheffield City Council (Consolidation) (On-Street Parking and Prohibition of Waiting) (Outer Area) Order 2008 (as amended) shall have effect as though:-

- (a) In Schedule 6.08 thereto the item was ‘13. Fulwood Road Service Road’ was deleted.
- (b) In Schedule 7.02 thereto the item was ‘2. Fulwood Road Service Road’ was deleted.
- (c) In Schedule 1.01H thereto for the item ‘1402 Fulwood Road Service Road (i) and (ii)’ there was inserted the following item:

1402. Fulwood Road Service Road The north west side:-

- (i) From its western end for a distance of 22 metres in a north easterly direction.
- (ii) From its eastern end for a distance of 20 metres in a south westerly direction.

(d) In Schedule 6.08 thereto for the item ‘17 Spooner Road’ there was substituted following item:-

42A.	The south side of Spooner Road which is bounded on the north east by so much of the edge of the carriageway of that highway from a point 7 metres west of the western kerb line of Crookes Road for a distance of 6.6 metres.			
44A.	The east side of Taptonville Road which is bounded on the north east by so much of the edge of the carriageway			

of that highway from a point 40 metres north-west of its junction with the northern kerb line of Fulwood Road for a distance of 7 metres in a northerly direction.

2. This Order shall come into operation on the 24th day of July, 2023 and may be cited as The Sheffield City Council (Consolidation) (On-Street Parking and Prohibition of Waiting) (Outer Area) Order 2008 (Amendment No.160) Order 2023
