## FEES

## **Premises Licences and Club Premises Certificates**

Fees are banded according to the Rateable Value of the premises.

In order to calculate the fee you need to pay, look for the rateable value of your property in the table below and that will give you the band for your licence fee.

The fee bands are : -

£4,301 to £33,000	В

#### Please Note: -

Where a premises is in the course of construction it will fall in Band C, and if not mentioned above it will fall in Band A.

When you have determined the correct band look at the chart below and that will give you the fee which must be sent with your application.
