

Introduction

This booklet lists sources available within Sheffield Libraries, Archives and Information for the study of the growth of the City of Sheffield through a series of boundary extensions.

Like other large cities, Sheffield experienced considerable population growth during the 19th century. By 1891 the population had grown from 110,891 in 1843 to 324,291. Although the original Borough covered a large area it included considerable areas that were unsuitable for development and already the population was expanding into the surrounding districts. Facilities such as parks and cemeteries were also being built beyond the existing boundaries.

In 1888 the Council's Committee as to Proposed Enlargement of the Borough was appointed and resolved 'that in the opinion of this Committee, it is desirable that certain adjacent outlying districts should be incorporated in the Borough.'

The first boundary extension was delayed until 1900 and, as the demand for land for housing, industry and services continued to grow, there were a number of further extensions through the 20th century. Other boundary changes were also made as a result of national reviews of the local government structure. Inevitably the city's expansion sometimes threatened the viability of smaller neighbouring authorities and local pride and loss of identity were often major factors in the campaigns organised by local councils and communities against proposed extensions.

This is not a detailed history of the subject; it merely points the reader who wishes to carry out their own research to what is available within Sheffield Libraries and Archives.


Details of Boundary Changes and Extensions

1901 Extension

In 1893 recommendations were made that the Council should apply for boundary extensions. The proposals were adopted in 1898 and it was decided to proceed by way of a local bill.

The Sheffield Corporation Act, 1900 secured all the extensions originally proposed. This included parts of Wortley Rural District (parts of the parishes of Ecclesfield, Wadsley and Bradfield), Rotherham Rural District (parts of the parishes of Tinsley and Catcliffe), Handsworth Urban District (part of Handsworth Parish) and Norton Rural District (parts of Norton Parish and the Liberty of Beauchief). The area was 4003 acres with a population of 24,866.

The Act also provided for the city to be divided into 16 wards and a Commissioner was appointed to determine the boundaries. The new wards were used for the elections on 1 November 1901 and they remained unchanged until 1929, apart from the addition of Handsworth Ward in 1921 and the inclusion in other wards of minor extensions made during this period.

1912 Extension

In 1912 part of the Parish of Tinsley, including the large steel works, was added to the city. An area of 691 acres with an estimated population of 5,270 was added to the Attercliffe Ward from 1 April 1912.

1914 Extension

The Sheffield Corporation Act, 1914 included provision for the city to acquire an area of 532 acres in the Rivelin Valley from Bradfield Parish.


1919 Extension

44 acres, comprising the site of the electricity station at Blackburn Meadows, were transferred from Rotherham. The site of Steel Peech & Tozer's works, acquired in the 1912 extension, was returned to Rotherham.

1921 Extension

After the war an ambitious scheme was proposed which would have involved extending the boundaries to include Rotherham and some of its adjacent parishes, Norton, Dronfield, Coal Aston, Beighton and Eckington and Wadsley Bridge, Ecclesfield and Chapeltown. Some of the proposals were dropped after discussions with the neighbouring authorities and, after a public enquiry in June 1920, the only areas acquired by Sheffield were Handsworth, the remainder of Tinsley, the Sheffield sewage works and Wadsley Bridge and Shiregreen. The extension amounted to 6,698 acres with a population of 21,328.

Handsworth became a separate, additional ward.

1929 Extension


The Sheffield Corporation Bill, 1928 originally proposed to extend the city by 8,728 acres but the area approved by Parliament was only 2,523 acres, comprising parts of the parishes of Hathersage, Derwent, Outseats and Dore and Totley.

In 1928 the Privy Council also granted a petition from the City Council that the city should be divided into 24 wards. The first elections took place on 1 November 1929.

1933 Extension

Most of the remaining parts of Norton Rural District, excluded from the 1928 Act, became part of the city under the Sheffield Extension Act, 1933. The area added was 5,433 acres with a population of about 7,314.

The Act provided for the creation of the new Norton Ward.

1937 Proposal

The Sheffield Corporation Bill, 1937 originally included a proposal to extend the boundaries to include the parishes of Aston-cum-Aughton and Todwick where land would be 'protected' for use as an aerodrome. These provisions were withdrawn.

1938 Boundary changes

Minor adjustments were made to the boundaries at Retford Road and Middlewood Road as a result of road widening schemes

1951 Proposal

Faced with a shortage of building land after the war, Sheffield proposed to add the Gleadless, Frecheville and Hackenthorpe areas of Chesterfield Rural District, where there were already housing estates, and also the whole of the Wortley Rural District. A private bill was promoted and although the demands on Wortley RDC were reduced to include only the Ecclesfield, Loxley and Stannington areas, the Bill failed to pass through the House of Lords.

In 1951 a scheme for the redistribution of wards was also proposed. The number of wards remained at 25 but some anomalies were removed and 3 new wards were created – Cathedral, Nether Shire and Southey Green.

1967 Extension

Following the failure of the Sheffield Extension Bill, 1951, Sheffield put its claim for boundary extensions to the Local Government Boundary Commission set up under the Local Government Act, 1958. Sheffield proposed to take Dronfield, Beighton, Eckington, Killamarsh and Unstone from Derbyshire and Parson Cross, Stannington and parts of the Loxley Valley from the West Riding. The neighbouring local authorities opposed these suggestions but a scheme was put before a public enquiry in July 1965 and the Boundary Commission's proposals were eventually accepted with minor amendments. The city boundaries were extended from April 1967 to include most of the Parish of Beighton, the Mosborough and Gleadless parts of Eckington, small parts of Holmesfield and Killamarsh and parts of Ecclesfield.

From 15 May 1967 the city's existing wards were replaced by 27 new wards.

1974 Extension

The Local Government Boundary Commission was dissolved in 1966 and a Royal Commission appointed to consider a more radical reorganisation of local government.

The Local Government Act which came into force on 1 April 1974 created the new Metropolitan County of South Yorkshire. The boundaries of the Metropolitan District of Sheffield were extended to include Stocksbridge Urban District and the parishes of Bradfield and Ecclesfield in Wortley Rural District. Proposals to incorporate Dronfield, Eckington and Killamarsh were dropped as the bill passed through Parliament.

1994 Boundary changes

Some minor changes were made to realign the boundaries and to unify certain areas within a single authority.

Newspapers

Relevant articles and features may appear in local newspapers. The main titles available at Sheffield Local Studies Library covering this period include the *Sheffield Daily Telegraph*, *Sheffield Independent* and the *Star*.

Some of the areas particularly affected by the extensions were also covered by the *Eckington, Woodhouse and Staveley Express* (from 1940 an edition of the *South Yorkshire Times*) and the *Penistone, Stocksbridge and Hoyland Express* (from 1940 an edition of the *South Yorkshire Times*)

Newspaper indexes are not available for the whole period. Sheffield Local Studies Library has a card index for the 1930s-1950s and from about 1960 to the present day there are cuttings files arranged by subject.

Archives of some national newspapers are available on the internet, notably *The Times* (http://archive.timesonline.co.uk) and *The Guardian* (http://archive.guardian.co.uk)

Council Minutes

Minutes of Sheffield City Council and its Committees include numerous references to boundary extensions. Discussion usually took place in the Parliamentary Committee or sometimes in a special committee appointed for the purpose, such as the City Extension Committee formed in 1919 (Sheffield Archives: CA-MIN; copies also available at Sheffield Local Studies Library: 352.02)
