1. This Instrument may be cited as “The Sheffield City Council (Bus Rapid Transit Northern Route—Tinsley Link—Fitzwilliam Bridge) Scheme 2012 Confirmation Instrument 2013” and shall come into force on the date on which notice that it has been confirmed is first published in accordance with paragraph 1 of Schedule 2 to the Highways Act 1980.

2. The Sheffield City Council (Bus Rapid Transit Northern Route—Tinsley^y Link—Fitzwilliam Bridge) Scheme 2012 Confirmation Instrument 2013 (“the Scheme”) is hereby confirmed.

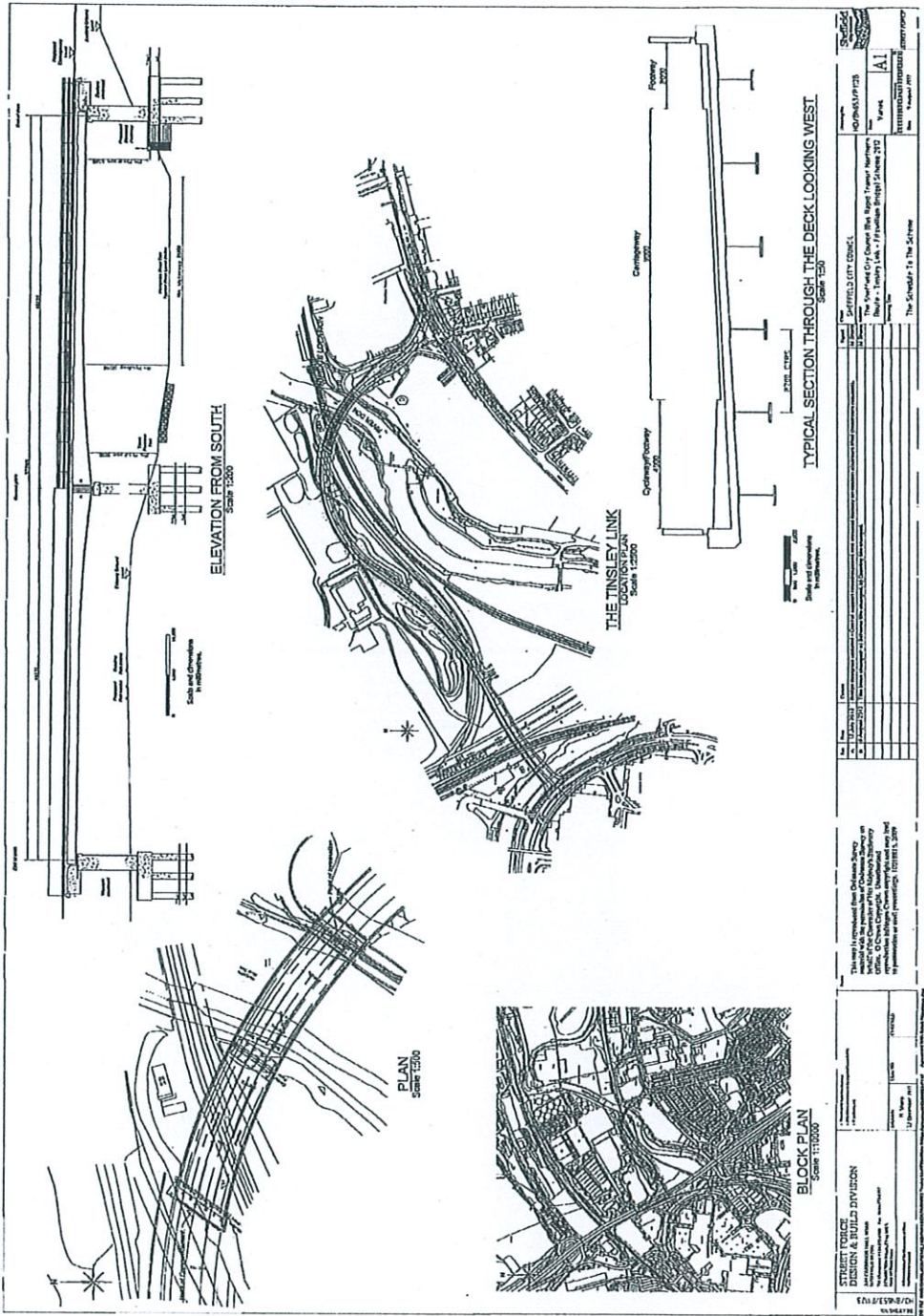
