THE SHEFFIELD CITY COUNCIL (STOPPING RESTRICTIONS, WAITING RESTRICTIONS, LOADING RESTRICTIONS & PARKING PLACES) (MAP SCHEDULE) ORDER 2024

PART I

The Sheffield City Council (hereinafter referred to as "the Council") under Sections 1; 2(1) to (3); 4(2); 32(1); 35(1); 45; 46; 46A; 49; 51; 53; and 124(1)(c), (d) and (f) of the Road Traffic Regulation Act 1984 (c.27) ("the Act") and of all other enabling powers, and after consulting the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby makes the following order:

1 Citation and commencement

1) This Order shall come into operation on the [] day of 2024 and may be cited as the Sheffield City Council (Stopping Restrictions, Waiting Restrictions, Loading Restrictions & Parking Places) (Map Schedule) Order 2024.

2 Definitions

1) In this Order:

"Additional Electric Vehicle Recharging Parking Place Charge" means a charge payable for using an Electric Vehicle Recharging Parking Place or Electric Taxi Recharging Parking Place and staying longer than the maximum period of stay, as specified in Column 6 of Table 1 in Part III of this Order;

"Bank Holiday" means any bank holiday or public holiday other than Good Friday;

"Bus" has the same meaning as in Schedule 1 of The Traffic Signs Regulations and General Directions 2016;

"Bus Parking Place" means the parts of the roads identified on the Plans in Schedule 2 as bus parking places which, subject to the provision of this Order, is provided for the leaving of a Bus and indicated by Traffic Signs;

"Business Operator" means the operator of a business or commercial enterprise operating out of premises at a postal address within any Parking Scheme, and includes:

- a) Sole traders;
- b) Limited companies and partnerships;
- c) Charities; and
- d) Community Organisations;

"Business Parking Permit" means a Physical or a Virtual Parking Permit issued by the Council to a Business Operator;

"Business Permitted Vehicle" means an eligible vehicle used by the holder of a Business Parking Permit in the manner directed by the Council in connection with that Business Parking Permit;

"Car Club Parking Permit" means a permit issued by the Council for a Car Club Vehicle left in a Car Club Parking Place and used in the manner directed by the Council;

"Car Club Parking Place" means the parts of the roads identified on the Plans in Schedule 2 as Car Club Parking Places which, subject to the provisions of this Order, is provided for the leaving of a Car Club Vehicle and as indicated by Traffic Signs;

"Car Club Vehicle" is a liveried vehicle provided for the use of persons who have paid the relevant membership fee and any other related charges by means of a real-time or advance booking system, so as to have access to the vehicle for a specific period or periods;

"Carer" means a mental health social worker visiting a patient who may need to be detained under the Mental Health Act; a primary care outreach nurse; a TB nurse; a health visitor; or a family support worker, as determined by the Council, who is providing care to a resident living at an address within any Parking Scheme;

"Carer's Parking Permit" means a Physical Parking Permit issued by the Council for use with an eligible vehicle used by a Carer;

"Carer's Permitted Vehicle" is an eligible vehicle used by the holder of a Carer's Parking Permit in the manner directed by the Council in connection with that Carer's Parking Permit;

"Car Free Property" means a property which is identified by the Council as a property where a Resident or Business Operator is ineligible for a Resident's Parking Permit or Business Operator's Parking Permit, respectively;

"Cashless Payment System" means the system used to facilitate, monitor and record the payment of Parking Charges using mobile telephone communication, software application or an online transaction with the Service Provider, in accordance with instructions given on signs, machines or by any other manner, as authorised by the Council, at Parking Places where the Cashless Payment System is in operation. Parking Charges paid by means of a Cashless Payment System may incur an additional charge, over and above the Parking Charge, which is determined by the Council;

"Charging Hours" means, with respect to the parts of the roads identified on Plans in Schedule 2 as Parking Places subject to a Parking Charge, the period detailed on those Plans during which a Parking Charge is to be paid for the leaving of a vehicle on any day save for a Bank Holiday;

"Charity" has the meaning given by s.1 of the Charities Act 2011;

"Community Organisation" means a not-for-profit body concerned with the social or welfare needs of one or more communities;

"Disabled Person's Badge" has the same meaning as in The Disabled Persons (Badges for Motor Vehicles) (England) Regulations 2000;

"Disabled Person's Parking Place" means the parts of the roads identified on the Plans in Schedule 2 as disabled person's badge holders parking places which, subject to the provisions of this Order, is provided for the leaving of a Disabled Person's Vehicle and indicated by Traffic Signs;

"Disabled Person's Vehicle" means a vehicle lawfully displaying a Disabled Person's Badge;

"Doctor's Parking Place" means the parts of the roads identified on the Plans in Schedule 2 as doctor's parking places which, subject to the provisions of this Order, is provided for the leaving of a Doctor's Vehicle and indicated by Traffic Signs;

"Doctor's Vehicle" is a vehicle registered to or leased by a doctor whose practice is located within the City of Sheffield, who is the main user of the vehicle and for which a valid Doctor's Parking Permit has been issued by the Council and is being used in the manner directed by the Council;

"Driver" in relation to a vehicle waiting in a Parking Place, Loading Bay or on a road or length of road, means the person driving the vehicle at the time it was left in the Parking Place, Loading Bay or on a road or length of road;

"Electric Private Hire Vehicle" means an Electric Vehicle which is also a Private Hire Vehicle;

"Electric Taxi" means an Electric Vehicle which is also a Taxi;

"Electric Taxi Recharging Parking Place" means the parts of the roads identified on the Plans in Schedule 2 as "electric taxi recharging point" which, subject to the provisions of this Order, is provided for the recharging of Electric Taxis and Electric Private Hire Vehicles and indicated by Traffic Signs and the presence of an Electric Vehicle Recharging Post;

"Electric Vehicle" means a vehicle that:

- a) is an exempt vehicle for the purposes of the Vehicle Excise and Registration Act 1994 in accordance with paragraph 20G (electrically propelled vehicles) of Schedule 2 to that Act; or
- the Council is satisfied is capable of operation wholly by means of an electrically powered propulsion system that draws its motive power from either a hydrogen fuel cell or from a battery without using its internal combustion engine;

"Electric Vehicle Recharging Parking Place" means the parts of the roads identified on the Plans in Schedule 2 as an "electric vehicle recharging point" which, subject to the provisions of this Order, are provided for the recharging of Electric Vehicles and indicated by Traffic Signs and the presence of an Electric Vehicle Recharging Post;

"Electric Vehicle Recharging Parking Place Charge" means a charge payable for using an Electric Vehicle Recharging Parking Place or Electric Taxi Recharging Parking Place, as specified in Column 4 of Table 1 in Part III of this Order;

"Electric Vehicle Recharging Post" means an installation, adjacent to an Electric Vehicle Recharging Parking Place or an Electric Taxi Recharging Parking Place for the purpose of recharging the battery of an Electric Vehicle by way of a connected lead, that can indicate that a payment has been made and it is in operation;

"Electric Vehicle Recharging Post Cashless Payment System" means the system used to facilitate and monitor the payment of an Electric Vehicle Recharging Parking Place Charge and Additional Electric Vehicle Recharging Parking Place Charge using mobile telephone communication, software application or an online transaction with the Service Provider, in accordance with instructions given on signs, machines or by any other manner, at Electric Vehicle Recharging Parking Places and Electric Taxi Recharging Parking Places, where the Electric Vehicle Recharging Post Cashless Payment System is in operation;

"Entrance Marking" means a length of road subject to a restriction identified in the Plans in Schedule 2 as "prohibition of stopping on school entrance markings" and marked out as such by way of the road

markings of the type shown in item 10 of Schedule 7, Part 4 to the Traffic Signs Regulations and General Directions 2016 and as indicated by Traffic Signs;

"Free Parking Place" means the parts of the roads identified on the Plans in Schedule 2 as a free parking place and as indicated by Traffic Signs;

"Footway" has the same meaning as in section 329(1) of the Highways Act 1980;

"Goods" includes any article, merchandise or postal packets of any description and "delivering" and "collecting" in relation to any Goods includes checking the Goods for the purposes of their delivery or collection;

"Goods Vehicle" means a Motor Vehicle not exceeding 30cwt unladen weight, which is constructed or adapted for use for the carriage of Goods of any description and is not drawing a trailer;

"Green Parking Permit" means a Physical Parking Permit issued by the Council for use with an eligible ultra low emission vehicle, as determined by the Council;

"Green Permitted Vehicle" is a vehicle used by the holder of a Green Parking Permit in the manner directed by the Council in connection with that Green Parking Permit;

"Initial Period" means the period of 20 minutes beginning with the time the vehicle was first left in a Parking Place subject to a Parking Charge in the Outer Area - Zone 3 and the Highfields zone;

"Loading Bay" means the parts of the roads identified on the Plans in Schedule 2 as a loading place and as indicated by road markings and Traffic Signs; .

"Motor Cycle" has the same meaning as in Section 136(4) of the Road Traffic Regulation Act 1984;

"NHS Parking Permit" means a Physical Parking Permit or a Virtual Permit obtained from the Council by an NHS organisation and issued by that organisation to an NHS medical practitioner for the use of a specified vehicle while treating patients;

"NHS Permitted Vehicle" is a vehicle used by the holder of an NHS Parking Permit in the manner directed by the Council in connection with that NHS Parking Permit;

"Outer Area - Zone 3" consists of the whole of the area of Sheffield except the City Centre – Inner Zone 1, City Centre – Outer Zone 2 and the Highfields zone;

"Paid-For Parking Place" means the parts of the roads identified on the Plans in Schedule 2 as paid-for parking places of any kind and as indicated by Traffic Signs;

"Parking Charge" means a charge, as specified in Article 8, Article 9 and Schedule 1, to be paid for a vehicle left in a Parking Place;

"Parking Dispensation" means a dispensation in respect of a Workshop Vehicle issued under the provisions of Article 16;

"Parking Disc" has the same meaning as in The Local Authorities' Traffic Orders (Exemptions for Disabled Persons) (England) Regulations 2000;

"Parking Place" means the parts of the roads identified on the Plans in Schedule 2 as parking places or parking areas of any kind and which, subject to the provisions of this Order, is provided for the leaving of a vehicle and indicated by Traffic Signs;

"Parking Place subject to a Parking Charge" means a Paid-For Parking Place where a charge, as specified in Article 8, Article 9 and Schedule 1 of this Order, must be paid for a vehicle left in that Parking Place during Charging Hours;

"Parking Permit" means a permit issued by the Council, which may be Virtual or Physical, for a vehicle left in a Parking Place and used in the manner directed by the Council;

"Parking Scheme" and "Resident's Parking Scheme" means a group of Parking Places and/or Permit Holders Parking Places defined in relation to a geographic area as specified below and in respect of which:

- a) restrictions on the parking of vehicles apply by reference to that group of Parking Places and/or Permit Holders Parking Places;
- b) permits issued in relation to a specified Parking Scheme are valid within the Parking Scheme concerned and other Parking Schemes as specified in the table below:

"Parking Voucher" means paper voucher issued by an organisation authorised by the Council, intended to be displayed in the Relevant Position and which must indicate that the Parking Voucher was issued by the Council, and the date, day of the week and month on which it is used, comprising either:

- a) a TH Voucher, valid for 1 hour with no return for 3 hours;
- b) a CH Voucher, valid for 4 hours;
- c) a FR Voucher, valid for one day;

"Passenger Vehicle" means a Motor Vehicle (other than a Motor Cycle or an invalid carriage) constructed solely for the carriage of passengers and their effects and adapted to carry not more than 8 passengers exclusive of the driver, and not drawing a trailer;

"Permit Holders Parking Place" means the parts of the roads identified on the Plans in Schedule 2 as permit holders parking places or resident permit holders parking places and as indicated by Traffic Signs which, subject to the provisions of this Order and during the Permit Holder's Operational Hours, is provided only for the leaving of a vehicle for which a valid Parking Permit has been issued to a Parking Permit holder:

"Permit Holder's Operational Hours" means the hours of operation specified in the Plans in Schedule 2 in respect of permit holders parking places and resident permit holders parking places, which apply on all days save for Bank Holidays;

"Permitted Hours" means the period (including times of day and maximum length of stay) during which a vehicle may be left in a Parking Place, whether that Parking Place is subject to a Parking Charge or not; as identified in on the Plans in Schedule 2 and indicated by Traffic Signs;

"Permitted Utility Vehicle" is an eligible vehicle used by the holder of a Utility Parking Permit in the manner directed by the Council in connection with that Utility Parking Permit;

"Physical Parking Permit" means a Parking Permit intended to be displayed in the Relevant Position;

"Plan" and "Plans" means any of the scaled drawings in Schedule 2 to the Order, which show:

- a) Parking Schemes; and
- b) the extent and type of each restriction that applies in this Order;

"Private Hire Vehicle" has the meaning given in section 80 of the Local Government (Miscellaneous Provisions) Act 1976;

"Police Stopping Area" means the parts of the roads identified on the Plans in Schedule 2 as a police vehicle stopping area;

"Police Vehicle" has the meaning given in paragraph 3A of Schedule 2 to the Vehicle Excise and Registration Act 1994;

"Relevant Position" means, with respect to a Physical Parking Permit, Parking Voucher, Ticket, Parking Disc or a Disabled Person's Badge displayed on a vehicle, a position whereby—

- a) they are exhibited on the dashboard or facia of the vehicle, or
- b) where the vehicle is not fitted with a dashboard or facia, they are exhibited in a conspicuous position on the vehicle;

so that the front of the Physical Parking Permit, Parking Voucher, Ticket, Parking Disc or Disabled Person's Badge is clearly legible from the outside of the vehicle;

"Resident" in respect of any Resident's Parking Place, means a person whose usual place of residence is at a postal address situated in a specified Parking Scheme identified above and set out in the Plans in Schedule 2;

"Resident's Parking Permit" means a Virtual Parking Permit issued by the Council to a Resident for the parking of a Passenger Vehicle, a Goods vehicle or a Motor Cycle in a Permit Holders Parking Place within a specified Parking Scheme or Schemes, or in respect of the Edward Street Flats Car Park or the Lansdowne Flats Car Park;

"Resident Permit Holders Parking Place" means the parts of the roads identified on the Plans in Schedule 2 as resident permit holders parking places and as indicated by Traffic Signs which, subject to the provisions of this Order and during the Permit Holder's Operational Hours, is provided only for the leaving of a Resident's Permitted Vehicle;

"Resident's Permitted Vehicle" means a vehicle used by the holder of a Resident's Parking Permit in the manner directed by the Council in connection with that Resident's Parking Permit;

"Resident's Carer's Permit" means a Physical Parking Permit obtained from the Council by a Resident and issued to a carer or carers providing that Resident with essential care at their place of residence;

"Resident Carer's Permitted Vehicle" means a vehicle used by the holder of a Resident's Carer's Parking Permit in the manner directed by the Council in connection with that Resident's Carer's Parking Permit;

"road" has the same meaning as that in Section 142 of the Road Traffic Regulation Act 1984;

"Service Provider" means a body appointed and authorised by the Council to administer, maintain and operate on its behalf the receipt of charges made using the Cashless Payment System;

"Shared Use Parking Place" means the parts of the roads identified on the Plans in Schedule 2 as Parking Places that may be used as a Permit Holders Parking Place or either a Free Parking Place or a Paid-for Parking Place, and as indicated by Traffic Signs;

"Solo Motor Cycle" has the same meaning as in the Traffic Signs Regulations and General Directions 2016;

"Solo Motor Cycle Parking Place" means the parts of the roads identified on the Plans in Schedule 2 as solo motor cycle parking places of any kind and which, subject to the provisions of this Order, is provided for the leaving of Solo Motor Cycles and as indicated by Traffic Signs;

"street" means the whole or any part of any highway, bridge carrying a highway, road, lane, mews, footway, alley, passage, square or court whether a thoroughfare or not;

"Taxi" has the meaning given in Schedule 1 of The Traffic Signs Regulations and General Directions 2016;

"Taxi Rank" means a Taxi Rank (No Waiting) or a Taxi Rank (No Stopping);

"Taxi Rank (No Stopping)" means the parts of the roads identified on the Plans in Schedule 2 as a "taxi stopping area (no stopping)";

"Taxi Rank (No Waiting)" means the parts of the roads identified on the Plans in Schedule 2 as a "taxi stopping area";

"Telephone Kiosk" means any kiosk, booth, acoustic hood, shelter or similar structure, which is erected or installed for the purpose of housing or supporting electronic communications apparatus and at which an electronic communications service is provided (or is to be provided) by an electronic communications code operator;

"Ticket" means a Ticket issued by a Ticket Issuing Machine relating to any Parking Place;

"Ticket Issuing Machine" means an apparatus designed to indicate the time externally and to issue numbered Tickets indicating the payment of a Parking Charge, the expiry of the period in respect of which the Parking Charge was paid and incorporating the identification mark of the machine from which the Ticket has been issued;

"Ticket Issuing Machine relating to a Parking Place" means a Ticket Issuing Machine from which a Ticket may be purchased for use of the Parking Place as indicated on Traffic Signs;

"Trade Parking Permit" means a Physical Parking Permit issued by the Council for use with an eligible trader's vehicle in a specified Parking Scheme or Schemes, as determined by the Council;

"Trade Permitted Vehicle" is a vehicle used by the holder of a Trade Parking Permit in the manner directed by the Council in connection with that Trade Parking Permit;

"Traffic Sign" means a sign or marking of any size, colour and type prescribed or authorised under or having effect as though prescribed or authorised under Section 64 of the Road Traffic Regulation Act 1984;

"Utility Parking Permit" means a Virtual or Physical Parking Permit issued by the Council for use with an eligible statutory undertaker's vehicle, as determined by the Council;

"Valid":

- a) in relation to a Parking Permit used in a Permit Holders Parking Place or Resident Permit Holders Parking Place means that, in addition to compliance with the provisions of this Order generally, the Permit has been issued in relation to the Parking Scheme within which the Permit Holders Parking Place is situated;
- b) in relation to a Parking Voucher means that in addition to compliance with the provisions of this Order generally, the Parking Voucher has been issued in relation to the Voucher Parking Place concerned;

"Virtual Parking Permit" means an electronic record of a payment made for a Parking Permit by any method provided by the Council;

"Visitor's Parking Permit" means a Physical Parking Permit purchased by a Resident and issued to visitors to their place of residence;

"Visitor's Permitted Vehicle" is a vehicle used by the holder of a Visitor's Parking Permit in the manner directed by the Council in connection with that Visitor's Parking Permit;

"Voucher Holder" means a person to whom a valid Parking Voucher has been issued by the Council;

"Voucher Holder's Vehicle" is vehicle used by a Voucher Holder in the manner directed by the Council in connection with that Voucher and displaying a valid Parking Voucher in the relevant position;

"Voucher Parking Place" means the parts of the roads identified on the Plans in Schedule 2 as a voucher bay and as indicated on Traffic Signs;

"Workshop Vehicle" means a vehicle that the Council has determined is required to be in close proximity to any premises:

- a) for health and safety reasons (including removal and loading of asbestos, carrying hazardous or dangerous chemicals for use at the premises, glass or window installation where a glass rack is fitted to the vehicle's side);
- Where the vehicle has apparatus fitted to the vehicle that is needed to carry out works adjacent to where the vehicle is parked (including generators, welding equipment, drainage pipes);
- c) for events agreed by the Council where the vehicle is being used as a support vehicle;
- d) because the vehicle is a filming set vehicle with equipment or apparatus needed for on-site filming; or
- e) because the vehicle is a roadside survey vehicle;

and in respect of which the Council has granted a Parking Dispensation.

2) Any reference in this Order to an enactment includes a reference to it as amended (whether before or after the date of this Order) and to any other enactments which may, after the date of this Order, directly or indirectly replace it, with or without amendment.

PART II - STOPPING, WAITING AND LOADING

3 Stopping restrictions

- 1) Save as provided in Article 13, no person shall, except upon the direction or with the permission of a Police Officer in uniform or of a Civil Enforcement Officer, cause or permit any vehicle to stop in the roads or sides of the roads, verges and footways subject to a restriction identified on the Plans in Schedule 2 as "no stopping at time" or "no stopping", during the periods identified on the Plans in Schedule 2.
- 2) Save as provided in Article 13, no person shall, except upon the direction or with the permission of a Police Officer in uniform or of a Civil Enforcement Officer, cause or permit any vehicle to stop in the roads, sides of the roads, verges and footways (excluding lay-bys) subject to a restriction identified on the Plans in Schedule 2 as a "clearway", or in any area subject to a restriction identified on the Plans in Schedule 2 as "no stopping on the footway" or "no stopping on the verge", during the periods identified on the Plans in Schedule 2.
- 3) Save as provided in Article 13, no person shall, except upon the direction or with the permission of a Police Officer in uniform or of a Civil Enforcement Officer, cause or permit any vehicle to stop in any Taxi Rank (No Stopping) during the periods identified on the Plans in Schedule 2.
- 4) Save as provided in Article 13, no person shall, except upon the direction or with the permission of a Police Officer in uniform or of a Civil Enforcement Officer, cause or permit any vehicle to stop in any Entrance Marking during the periods identified on the Plans in Schedule 2.

4 Waiting Restrictions

- 1) Save as provided in Article 13, no person shall, except upon the direction or with the permission of a Police Officer in uniform or of a Civil Enforcement Officer, cause or permit any vehicle to wait in the roads or sides of the roads subject to restrictions identified on the Plans in Schedule 2 as "no waiting", "no waiting at any time", or in any area subject to a restriction identified on the Plans in Schedule 2 as "no waiting on the footway" or "no waiting on the verge", during the periods identified on the Plans in Schedule 2.
- 2) Save as provided in Article 13, no person shall, except upon the direction or with the permission of a Police Officer in uniform or of a Civil Enforcement Officer, cause or permit any vehicle to wait in any Taxi Rank (No Waiting) during the periods identified on the Plans in Schedule 2.
- 3) Save as provided in Article 13, no person shall, except upon the direction or with the permission of a Police Officer in uniform or of a Civil Enforcement Officer, cause or permit any vehicle to wait in any Police Stopping Area during the periods identified on the Plans in Schedule 2.

5 Loading Restrictions

1) Save as provided in Article 13, no person shall, except upon the direction or with the permission of a Police Officer in uniform or of a Civil Enforcement Officer, cause or permit any vehicle to load or unload in the roads or sides of the roads subject to restrictions identified on the Plans in Schedule 2 as 'no loading' during the periods identified on the Plans in Schedule 2.

6 Loading Bays

1) Save as provided in Article 13, the parts of the roads identified on the Plans in Schedule 2 as a 'loading place' are authorised to be used only subject to the provisions, in such positions and during such periods as identified on the Plans in Schedule 2, for the purpose of delivering and collecting Goods, or continuously loading or unloading the vehicle, at the premises adjoining that road.

PART III - PARKING PLACES

7 Designation and use of Parking Places

- Parking Places are authorised to be used, subject to the provisions of this Order, for parking such vehicles in such positions and during the Permitted Hours as identified in this Order and the Plans in Schedule 2.
- Certain Parking Places are reserved for the use during the Permitted Hours of specified vehicles as follows:
 - a) Permit Holders Parking Places other than Shared Use Parking Places may be used only during Permit Holder's Operational Hours:
 - i) in the case of a Resident's Parking Place, for the leaving of a Resident's Permitted Vehicle with a Resident's Parking Permit that is valid for that Parking Place;
 - ii) in the case of any other Permit Holders Parking Place, for the leaving of a Resident's Permitted Vehicle with a Resident's Parking Permit that is valid for that Parking Place or a Business Permitted Vehicle with a Business Parking Permit that is valid for that Parking Place:
 - b) Except on Bank Holidays, Shared Use Parking Places may only be used (i) where the Parking Place is a used as a Permit Holders Parking Place, for the leaving of a vehicle that meets the criteria in paragraph (a);(ii) where the Parking Place is used as a Paid-For Parking Place, subject to the payment of a Parking Charge in accordance with Article 8, or (iii) where the Parking Place is used as a Free Parking Place, in accordance with paragraph (j) below;
 - c) Voucher Parking Places may be used only by Voucher Holder's Vehicles;
 - d) Car Club Parking Places may be used only by Car Club Vehicles;
 - e) Doctor's Parking Places may be used only by Doctor's Vehicles;
 - f) Bus Parking Places may be used only by Buses;
 - g) Solo Motor Cycle Parking Places may be used only by Solo Motor Cycles;
 - h) Electric Vehicle Recharging Parking Places may be used only by electric vehicles in accordance with Article 9:
 - i) Electric Taxi Recharging Places may be used only by Electric Taxis and Electric Private Hire Vehicles in accordance with Article 9;
 - j) Free Parking Places may be used by Passenger Vehicles, Goods Vehicles Motor Cycles and Disabled Person's Vehicles in accordance with Traffic Signs; and
 - k) Disabled Person's Parking Places may be used only by Disabled Person's Vehicles in accordance with Traffic Signs.
- 3) Parking Places subject to a Parking Charge may be used only in accordance with Article 8.

- 4) Save as provided in Article 13, no person shall cause a vehicle to stop or wait in a Parking Place:
 - a) if the vehicle is not parked wholly within the limits of the Parking Place;
 - b) if the vehicle is using the Parking Place in connection with the sale of any Goods to any person in or near the Parking Place, in connection with the selling or offering for sale of their skill in handicraft, or their services in any other capacity, unless licensed by the Council to sell Goods from a stationary pitch situated in the Parking Place;
 - c) if the vehicle is parked in a Disabled Person's Parking Place and is not displaying a valid Disabled Person's Badge in the Relevant Position;
 - d) where the vehicle is parked in reliance on a Physical Parking Permit or a Parking Voucher, if that Physical Parking Permit or Parking Voucher is not displayed in the Relevant Position that relates to and is valid for that Parking Place;
 - e) Save in relation to a Bus Parking Place, if the vehicle:
 - i) has an unladen weight exceeding 3500kg; or
 - ii) exceeds 2.3m in overall height; or
 - iii) exceeds 5.25m in overall length; or
 - f) if the vehicle is drawing a trailer;
 - g) if a Parking Permit, Disabled Person's Badge, Parking Voucher, Parking Disc and/or Ticket, either displayed in the Relevant Position or not, is used and has been obtained by fraud;
 - h) if the engine of the vehicle is not stopped as soon as the vehicle is in position in the Parking Place and provided that the engine is not started again except when about to change the position of the vehicle in or to depart from the Parking Place; or
 - i) if using the Parking Place for the purpose of servicing, painting or maintaining the vehicle, other than as is reasonably necessary to enable the vehicle to depart from that Parking Place.

8 Parking Places subject to a Parking Charge

- 1) Save as provided in Article 13, the Driver of any vehicle using any Parking Place subject to a Parking Charge during the Charging Hours shall pay the Parking Charge detailed in Schedule 1.
- 2) Subject to the provisions of this Order and as indicated by Traffic Signs, Payment of the Parking Charge for a vehicle left in a Parking Place shall be indicated by either:
 - a) the issue of a Ticket by a Ticket Issuing Machine relating to that Parking Place and by the display of that Ticket in the Relevant Position; or
 - b) a record of payment produced by the Cashless Payment System which shows that the Parking Charge was paid for that Parking Place.

- 3) If, at the time when a vehicle is left in a Parking Place, every Ticket Issuing Machine relating to that Parking Place is out of order then the Parking Charge must be paid by means of a Cashless Payment System, if available.
- 4) Save as provided in Article 13 no person shall cause a vehicle to stop or wait in a Parking Place, subject to a Parking Charge during Charging Hours if the vehicle:
 - a) is not displaying in the Relevant Position a valid Ticket applicable for the time and Parking Place and which indicates that either the Initial Period, or the period for which the Parking Charge for that Parking Place was paid, has not expired; or
 - b) has not used the Cashless Payment System provided by the Council and indicated on signs adjacent to the Parking Place to pay the Parking Charge for that Parking Place, and the period for which the Parking Charge for that Parking Place was paid has not expired; or
 - has not been registered with a Virtual Parking Permit that relates to and is valid for that Parking Place; or
 - d) is not displaying a Physical Parking Permit in the Relevant Position that relates to and is valid for that Parking Place; or
 - e) is displaying a Ticket acquired for the purpose of enabling another vehicle to use any Parking Place and the Ticket has been transferred from that vehicle, or from a Ticket Issuing Machine that does not relate to the Parking Place concerned; or
 - f) has been in the Parking Place concerned for longer than the period of maximum stay relating to that Parking Place as indicated on Traffic Signs; or
 - g) has previously parked in the Parking Place concerned within the period of no return relating to that Parking Place as indicated on Traffic Signs; or
 - h) is parked in a Parking Place during Charging Hours and the vehicle has displayed more than one free Ticket for the Initial Period for that vehicle on that day.

9 Electric Vehicle and Electric Taxi Recharging Parking Places

- Each Electric Vehicle Recharging Parking Place and Electric Taxi Recharging Parking Place is designated as a Parking Place for the days and hours listed in Column 1 of Table 1 for a maximum period of stay listed in Column 2 for the classes of vehicle stated in Column 3.
- 2) Save as provided in Article 13, no person shall cause or permit a vehicle to wait in an Electric Vehicle Recharging Parking Place or an Electric Taxi Recharging Parking Place, unless it is connected to an Electric Vehicle Recharging Post by a connecting lead and the Electric Vehicle Recharging Post indicates the vehicle is actively recharging.
- 3) The Electric Vehicle Recharging Parking Place Charge for a vehicle left in an Electric Vehicle Recharging Parking Place or an Electric Taxi Recharging Parking Place is as described in Column 4 of Table 1 in relation to the length of stay shown in Column 2, with a return prohibited time indicated in Column 5. A subsequent Additional Electric Vehicle Recharging Parking Place Charge, as shown in Column 6 of Table 1, is payable if the vehicle stays longer than the maximum period of stay indicated in Column 2.

4) The Driver of a vehicle left in an Electric Vehicle Recharging Parking Place or Electric Taxi Recharging Parking Place shall make a payment for the Electric Vehicle Recharging Parking Place Charge and the Additional Electric Vehicle Recharging Parking Place Charge through the Electric Vehicle Recharging Post Cashless Payment System.

10 Residents and Business Parking Permits

- Any Resident of any premises situated in the Holme Lane or Loxley New Road Parking Schemes that is not a Car Free Property may apply to the Council for the issue of one Resident's Parking Permit per household.
- 2) Save in exceptional circumstances, any Resident of any premises situated on roads within a Parking Scheme not falling within paragraph (1) that is not a Car Free Property may apply to the Council for the issue of up to two Resident's Parking Permits per household, and in exceptional circumstances the Council may consider an application for a third Resident's Parking Permits for a given household.
- 3) Any Business Operator situated within a Parking Scheme other than City Centre Inner Zone 1, City Centre – Outer Zone 2, Falding Street zone, Holme Lane zone, Loxley New Road or Vaughton Hill may apply to the Council for the issue of a Business Parking Permit relating to a specified Parking Scheme.

- 4) The Council may require an applicant for a Parking Permit to produce to an officer of the Council such evidence in respect of the application as they may reasonably require, and which verifies any particulars or information given to them.
- 5) A Parking Permit issued under this article may be specific to a Parking Scheme or Schemes, and where that is the case the Parking Permit is only considered valid where it is used for the leaving of a vehicle in a Parking Place or Permit Holders Parking Place which is part of that Parking Scheme or those Parking Schemes.
- 6) An application for a Parking Permit shall be accompanied by a payment of a charge, the amount of which is determined by the Council.
- 7) The Council, upon being satisfied that an applicant is eligible, may issue them a Parking Permit for the parking in a Parking Place of a vehicle of a relevant class.
- 8) A Parking Permit holder shall surrender a Physical Parking Permit to the Council, or the Council may revoke a Virtual Permit, at any time if one or more of the following circumstances prevails:
 - a) the Parking Permit holder ceases to be a Resident or Business Operator;
 - b) the details of the vehicle registration number no longer relate to the vehicle in respect of which the Parking Permit is to be used;
 - c) the Parking Permit holder causes or permits the Parking Permit to be used for reward;
 - d) in the opinion of the Council, the use of the Parking Permit has been abused;
 - e) a Physical Parking Permit is mutilated or defaced, or the figures or particulars on it have become illegible, or the colour of the Parking Permit has become altered by fading or otherwise;
 - f) if the Parking Permit is specific to a Parking Scheme, the Parking Permit holder moves to a different address within the same Parking Scheme.
- 9) A Parking Permit shall cease to be valid once the Council has requested of a Permit holder that the Parking Permit be surrendered to the Council.

11 Suspension of Parking Places and Loading Bays

- 1) The Council may, on application under paragraph (2) or otherwise, suspend the use of a Parking Place, Loading Bay or Taxi Rank, or any part thereof, if such suspension is considered by the Council to be reasonably necessary for:
 - a) the purpose of facilitating the movement of traffic or promoting its safety;
 - b) the purpose of any works adjacent to the Parking Place or Loading Bay;
 - c) the convenience of occupiers of premises adjacent to the Parking Place or Loading Bay;
 - d) any occasion on which it is likely by reason of some special attraction that any street will be thronged or obstructed;

- e) the convenience of occupiers of premises adjacent to the Parking Place at times of weddings or funerals, or on other special occasions;
- f) facilitating sporting events, social events or entertainment;
- g) to allow maintenance of an adjacent property where highway access is required for deliveries, skips etc;
- h) maintenance to trees;
- i) at the request of the police;
- j) security reasons;
- k) filming;
- I) the removal of furniture from one office or dwellinghouse to another or the removal of furniture from such premises to a depository or to such premises from a depository; or
- m) any other reason the Council considers acceptable.
- 2) Where any person wishes the Council to suspend the use of a Parking Place, Loading Bay or Taxi Rank, or any part thereof, the Council will require an application to be made within fourteen days of the proposed start date for the suspension with details of the request including:
 - a) the reasons for the suspension;
 - b) the proposed dates of the suspension;
 - c) the location or locations of the suspension;

and a charge will be payable, the amount of which is determined by the Council having regard to the nature and extent of the suspension.

- 3) Where the use of a Parking Place, Loading Bay or Taxi Rank, or any part thereof, has been suspended pursuant to paragraph (1), the Council or any person authorised on its behalf shall place or cause to be placed a Traffic Sign in or adjacent to that Parking Place, Loading Bay or Taxi Rank, indicating that it is suspended and that stopping or waiting by vehicles is prohibited.
- 4) No person shall cause or permit any vehicle to stop or wait in any Parking Place Loading Bay or Taxi Rank, or any part thereof, if the use of it has been suspended and a Traffic Sign has been placed in or adjacent to that Parking Place, Loading Bay or Taxi Rank indicating that it is suspended, unless that person is authorised to use it by the Council, with the exception of exemptions specified in paragraphs (1)(a) and (1)(b) of Article 13.

12 Applications for dispensations for Workshop Vehicles

1) The Council may require applications for Parking Dispensations in relation to a Workshop Vehicle to be made within seven days of the start date to an officer of the Council with details of the request including the reasons, dates and location for the Parking Dispensation; and including payment of a charge, the amount of which is determined by the Council having regard to the nature and extent of the Parking Dispensation.

2) Such Parking Dispensations must be used in the manner directed by the Council and failure to do so may result in the Parking Dispensation being revoked.

PART IV - EXEMPTIONS

13 Exemptions

- 1) Nothing in Articles 3 to 10 of this Order shall apply to a vehicle:
 - a) vehicle where the person in control of the vehicle is:
 - i) required by law to stop;
 - ii) obliged to stop to prevent an accident;
 - iii) prevented from proceeding by circumstances outside their control; or
 - iv) caused or permitted to stop or wait upon the direction or with the permission of a Police Officer in uniform;
 - b) for so long as may be necessary to enable the vehicle to be used for one of the following purposes:
 - i) fire and rescue authority;
 - ii) Scottish Fire and Rescue Service;
 - iii) traffic officer;
 - iv) ambulance;
 - v) providing a response to an emergency at the request of an NHS ambulance service;
 - vi) bomb or explosive disposal;
 - vii) special forces;
 - viii) police;
 - ix) National Crime Agency.
- 2) Nothing in Articles 3(1) to (3) or Articles 4 to 10 of this Order shall apply:
 - a) for so long as may be necessary to enable a vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in the service of a local authority or of a statutory undertaker in pursuance of statutory powers or duties, and subject to requirements of the Council's street works permit scheme;
 - b) for so long as may be necessary to enable a vehicle to be used for the purpose of delivering or collecting postal packets as defined in Section 125(1) of the Postal Services Act 2000 from an adjacent property; or
 - c) to a vehicle waiting only for so long as may be necessary to enable it to be used in connection with the removal of any obstruction to traffic.

- 3) Nothing in Article 3(1) shall apply:
 - a) To a Taxi or Private Hire Vehicle stopping for so long as may be necessary to enable a person or persons to board or alight from the vehicle or to load thereon or unload therefrom their personal luggage; or
 - b) in respect of a person causing or permitting a vehicle displaying a disabled person's badge in the relevant position to stop for so long only as may be required to enable a disabled person to get in to or out of the vehicle.
- 4) Nothing in Article 3(3) shall apply if the vehicle is a Taxi waiting upon a Taxi Rank (No Stopping) for the purposes of collecting or dropping off passengers or plying for hire, provided that the Driver of the vehicle:
 - a) shall park wholly within the limits of the Taxi Rank facing in the direction of traffic; and
 - b) shall stop the engine as soon as the vehicle is in position in the Taxi Rank and shall not start the engine except when about to change position of the vehicle in, or to depart from, the Taxi Rank.
- 5) Nothing in Article 4(2) shall apply if the vehicle is a Taxi waiting upon a Taxi Rank (No Waiting) for the purposes of collecting or dropping off passengers or plying for hire, provided that the Driver of the vehicle:
 - a) shall park wholly within the limits of the Taxi Rank facing in the direction of traffic; and
 - b) shall stop the engine as soon as the vehicle is in position in the Taxi Rank and shall not start the engine except when about to change position of the vehicle in, or to depart from, the Taxi Rank.
- 6) Nothing in Article 4(3) shall apply if the vehicle is a Police Vehicle.
- 7) Nothing in Articles 3(1) and (2) or Articles 4 to 10 shall apply to a vehicle while any gate or other barrier at the entrance of the premises to which the vehicle requires access or from which it has emerged is being opened or closed, if it is not reasonably practicable for the vehicle to wait in any other place while such gate or barrier is being opened or closed.
- 8) Nothing in Articles 4 to 10 shall apply to a vehicle:
 - a) if the vehicle is a Workshop Vehicle;
 - b) if the vehicle is a pedal cycle and is not located within a Taxi Rank, Police Stopping Area, Parking Place, or Loading Bay;
 - where authorised by the Council and only for so long as may be necessary to enable the vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in connection with building, industrial or demolition operations;
 - d) for so long as may be necessary to enable a person or persons to board or alight from the vehicle or to load thereon or unload therefrom their personal luggage, provided that the Driver

should remain with the vehicle unless the passenger needs support due to mobility or safeguarding matters.

- 9) Nothing in Article 4 or Articles 7 to 10 shall apply if a vehicle is being used for the purpose of delivering or collecting Goods or for continuously loading or unloading a vehicle for which the vehicle is required in either a commercial context, and/or due to the Goods being heavy or bulky, and provided that the vehicle does not wait for such purpose longer than is reasonably necessary
- 10) Nothing in Article 4, 6, Article 7(2)(a) or Article 7(2)(b) (insofar as that paragraph relates to a Permit Holders Parking Place) shall apply if the vehicle is a Disabled Person's Vehicle which displays in the Relevant Position a Disabled Person's Badge, and a Parking Disc (on which the Driver, or other person in charge of the vehicle, has marked the time at which the period of waiting began) for a period not exceeding 3 hours (not being a period separated by an interval of less than 1 hour from a previous period of waiting by the same vehicle in the same road on the same day).
- 11) Nothing in Article 7(2)(j) shall apply if the vehicle is a Disabled Person's Vehicle, which displays in the Relevant Position a Disabled Person's Badge and, if the Parking Place concerned is subject to a period of maximum stay as indicated by Traffic Signs, a Parking Disc (on which the Driver, or other person in charge of the vehicle, has marked the time at which the period of waiting began) provided that where the Traffic Sign concerned displays the disabled badge holder symbol a Disabled Person's Vehicle may only park for the period of maximum stay as indicated on the Traffic Sign concerned.
- 12) Nothing in Article 7(3) or Article 8 shall apply:
 - a) if the vehicle is a Disabled Person's Vehicle which displays in the Relevant Position a Disabled Person's Badge;
 - b) in respect of a Permitted Utility Vehicle using a Parking Place subject to a Parking Charge within the City Centre Inner Zone 1 or the City Centre Outer Zone 2.
- 13) Nothing in Article 4 shall apply:
 - a) to any vehicle, other than a privately owned vehicle, which is being used as an official vehicle for the purpose of a wedding (bridal vehicle) or funeral (hearse and cortege) at a location where a ceremony is taking place; or
 - b) if the vehicle is in use on a road in connection with the servicing of Telephone Kiosks adjacent to that road.
- 14) Nothing in Article 5 shall apply:
 - a) to any vehicle while the vehicle is in use in connection with the collection or delivery of Goods, which cannot reasonably be loaded or unloaded outside of the periods identified on the Plans in Schedule 2 provided that notice is given at least seven days in advance to the Council and the Council's consent is obtained; or
 - b) where the vehicle concerned is being operated by a company carrying out activities for which it is licensed by the Security Industry Authority, and provided that the vehicle does not wait for longer than is reasonably necessary.

- 15) Nothing in Articles 6 to 10 of this Order shall apply to a vehicle if the vehicle is waiting only for so long as is necessary to enable it to be used in connection with posting or removing advertising material in the form of posters on billboards, or the maintenance of electronic advertising displays or cleaning windows using a van mounted window cleaning system at premises adjacent to the road in which the vehicle is waiting.
- 16) Nothing in Article7(2)(a), or Article 7(2)(b) (insofar as that paragraph relates to a Permit Holders Parking Place), shall apply if the vehicle is:
 - a) an NHS Permitted Vehicle which displays in the Relevant Position a Parking Disc (on which the Driver, or other person in charge of the vehicle, has marked the time at which the period of waiting began) for a period not exceeding 2 hours (not being a period separated by an interval of less than 1 hour from a previous period of waiting by the same vehicle in the same road on the same day);
 - b) a Carer's Permitted Vehicle left in any Permit Holders Parking Place other than one situated in the City Centre – Inner Zone 1, the City Centre – Outer Zone 2, the Falding Street zone, the Holme Lane zone, Loxley New Road or the Vaughton Hill zone, which displays in the Relevant Position a Parking Disc (on which the Driver, or other person in charge of the vehicle, has marked the time at which the period of waiting began) for a period not exceeding 2 hours (not being a period separated by an interval of less than 1 hour from a previous period of waiting by the same vehicle in the same road on the same day);
 - c) a Resident Carer's Permitted Vehicle when parked in a Permit Holders Parking Place within any Parking Scheme within which the relevant Resident's Permitted Vehicle may park, other than a Parking Place situated in the City Centre – Inner Zone 1, the City Centre – Outer Zone 2, the Falding Street zone, the Holme Lane zone, Loxley New Road or the Vaughton Hill zone;
 - d) a Trade Permitted Vehicle; or
 - e) a Visitor's Permitted Vehicle when parked in a Permit Holders Parking Place within any Parking Scheme within which the relevant Resident's Permitted Vehicle may park.
- 17) Nothing in Article 8 of this Order shall apply to:
 - a) a Resident's Permitted Vehicle holding a Resident's Parking Permit for the City Centre Inner Zone 1 when parked in any Parking Place subject to a Parking Charge in the City Centre – Inner Zone 1 or the City Centre – Outer Zone 2;
 - a Resident's Permitted Vehicle holding a Resident's Parking Permit for the City Centre Outer Zone 2 when parked in any Parking Place subject to a Parking Charge in the City Centre – Outer Zone 2.
- 18) No Parking Charge shall be payable in respect of any vehicle:
 - a) waiting in a Parking Place subject to a Parking Charge in accordance with the provisions of Article 8;
 - b) which displays in the Relevant Position a valid Disabled Person's Badge and is left in a Parking Place during the Charging Hours;

- c) which displays in the Relevant Position a valid Physical Parking Permit or had been registered with a Virtual Parking Permit that relates to and is valid for that Parking Place; or
- d) which is left in a Parking Place subject to a Parking Charge at a time when there is no functioning Ticket Issuing Machine relating to that Parking Place and a Cashless Payment System is not signed or operational at that location, provided the vehicle concerned is removed within the Initial Period, which shall not commence until a Ticket Issuing Machine relating to that Parking Place is rectified or the Cashless Payment System becomes operational, whichever is the earlier.
- 19) Nothing in Article 7(2)(a), 7(2)(b) (insofar as that paragraph relates to a Permit Holders Parking Place), 7(2)(j), or 7(3), shall apply when Goods are being sold from the vehicle by a person who is licensed by the Council to sell Goods from a stationary pitch situated in a Parking Place.

PART IV - CONTRAVENTION & PENALTY CHARGES

14 Contraventions and penalty charge

1) If there is any contravention of any of the provisions of Articles 3 to 9 or 11(4), a penalty charge will be payable in accordance with Article 15.

15 Period after which a further penalty charge notice may be issued

1) Any vehicle left in contravention of the provisions of Articles 3 to 9 or 11(4) of this Order, pursuant to Article 14, may incur a penalty charge notice issued by a Civil Enforcement Officer. A further penalty charge in respect of the same offence may be incurred for each 24-hour period thereafter during which the same vehicle remains in the same Loading Bay, Parking Place or otherwise remains in contravention of the provisions of this Order.

16 Removal of vehicles

- When a vehicle is left in any road in contravention of any of the provisions contained in this Order the Council may move or remove, or arrange to be moved or removed, that vehicle from or within that Parking Place or road.
- 2) Any person moving a vehicle by virtue of this article:
 - a) may do so in any manner to reasonably alter its position; and
 - b) shall make any arrangements as may be reasonably necessary for the safe custody of the vehicle and the Council may recover any costs involved as a civil debt.

PART V - REVOCATIONS

17 The Orders specified in Schedule 3 are revoked.
