 Prohibition of Waiting At Any Time on parts of Back Lane, Bawtry Road, Baxter Road, Baxter Mews, Birley Spa Lane, Clough Fields, Crowder Avenue, Darwin Lane, Edensor Road, Handsworth Road, Hillfoot Road, Hoyland Road, Longley Farm View, Longley Lane, Marlcliffe Road, Newburn Drive, New Street, Northlands Road, Norwood Avenue, Sandbed Road, Sharrow Vale Road, Shiregreen Lane, Siemens Close, Southey Hill, Spring Water Drive, Vulcan Road, Vulcan Road south east leg, Vulcan Road north east leg, Wadsley Lane;

And remove:

- No Waiting Monday to Saturday 8am to 6.30pm on part of Sharrow Vale Road.

Baslow Road (service road by no.15-71) - Adjustments to the measurements of the existing restrictions are to formalise the Traffic Regulation Order. No Plan

Bawtry Road, Newburn Drive and Siemens Close - The proposed no waiting at any time restriction is required to facilitate the movement of traffic and to improve visibility at the junctions for all road users. TR-22-BR

Baxter Road and Baxter Mews - The proposed no waiting at any time restriction is required to facilitate access/egress from commercial units and to improve access and visibility at junctions for all road users. TR-22-BM

Clough Fields and Back Lane - The proposed no waiting at any time restriction is required to prevent obstructive parking occurring around at the junction with Back Lane and to improve visibility and safety for all road users. TR-22-CF

Darwin Lane - The proposed no waiting at any time restriction is required to facilitate the movement of traffic for all road users opposite Tapton Secondary School accesses. Adjustments to the measurements of other existing restrictions are to formalise the Traffic Regulation Order. TR-22-DL

Handsworth Road adjacent to No 35 - The proposed no waiting at any time restriction and the removal of no waiting Monday to Saturday 8am – 6.30pm is required to facilitate access/egress to commercial premises. TR-22-HR

Hoyland Road, Sandbed Road and Hillfoot Road - The proposed no waiting at any time restriction is required to prevent obstructive parking occurring at unsuitable locations in the area and to improve safety, access and visibility for all road users. TR-22-HRN

Longley Lane and Longley Farm View - The proposed no waiting at any time restriction is required to prevent obstructive parking occurring at unsuitable locations along the road and to improve visibility and safety for all road users at junctions and accesses. TR-22-LL

New Street - The proposed no waiting at any time restriction is required to facilitate improved access to commercial units and to improve access and visibility at the junction for all road users.

Norwood Avenue and Edensor Road – The proposed no waiting at any time restriction is required to facilitate the movement of traffic and improve visibility at the junction for all road users. TR-22-NR **Sharrow Vale Road** – the proposed no waiting at any time restriction and removal of no waiting Monday to Saturday 8am to 6.30pm restriction is required to facilitate access/egress from Dyson Place.
