- Prohibition of Waiting At Any Time on parts of Brookhouse Hill and Long Causeway;
- No stopping on Verge or footway at any time on parts of Long Causeway.

The Sheffield City Council in exercise of its powers under Section 1(1), 2(1) to (3), 4 (2), 32(1), 35(1), 45, 46, 46A, 49, 51, 53 and 124 (1) (c) (d)and (f) of the Road Traffic Regulation Act 1984 (c.27) ("the Act") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby makes the following Order:-

- 1. The Sheffield City Council (Consolidation) (On-Street Parking and Prohibition of Waiting) (Outer Area) Order 2008 (as amended) shall have effect as though:-
 - a) In Part II Waiting and Loading Restriction Article 3 thereto, there was included the following items:
 - j) Save as provided in Article 3 k) no person shall, except upon the direction or with the permission of a civil enforcement officer, cause or permit any vehicle to stop on the verge or footway of a carriageway as specified in the Schedule listed in Column 1 of Table 1B to this Order during the times relating to that Schedule as specified in Column 2 of that Table.
 - k) Nothing in Article 3 j) shall render it unlawful for a vehicle to wait if it is doing so in circumstances provided for in the exemptions listed in Column 3 to Table 1B related to the Schedules listed in Column 1 and described in Article 6 to this Order.
 - I) Nothing in Article 3 j) shall render it unlawful for a vehicle to stop in any road specified in any Schedule listed in Column 1 to Table 1B to enable the vehicle to be used for the fire brigade, ambulance or police in an emergency.
 - b) There was included the following table:-

- c) In Schedule 1.01C thereto there were included the following items:- 189C. Brookhouse Hill Both sides:
 - (i) From a point 116 metres south east of its junction with the south eastern kerb line of Whiteley Lane for a distance of 35 metres in a south easterly then south westerly direction.

577A. Long Causeway

- The north sides:
- (i) From its junction with Redmires Road to a point 360 metres west of its junction with the projected western kerb line of Soughley Lane.
- (ii) From a point 1963 metres west and south of its junction with the western kerb line of Soughley Lane for a distance of 39 metres in a southerly direction.

The south side:

- (i) From its junction with the western kerb line of Soughley Lane for a distance of 344 metres in a westerly direction.
- (ii) From a point 1176 metres west of its junction with the western kerb line of Soughley Lane for a distance of 48 metres in a westerly direction.
- (iii) From a point 1963 metres west and south of its junction with the western kerb line of Soughley Lane for a distance of 39 metres in a southerly direction.
- d) There was included the following Schedule:-<u>SCHEDULE 14.01</u>

NO STOPPING ON VERGE OR FOOTWAY - AT ANY TIME

Long Causeway

The north side:

- (i) From a point 360 metres west of its junction with the projected western kerb line of Soughley Lane for a distance of 390 metres in a westerly direction.
- (ii) From a point 810 metres west of its junction with the projected western kerb line of Soughley Lane for a distance of 414 metres in a westerly direction.

The north and west side:

(i) From a point 1280 metres west of its junction with the projected western kerb line of Soughley
Lane for a distance of 722 metres

in a westerly then southerly direction.

The south side:

- (i) From a point 344 metres west of its junction with the western kerb line of Soughley Lane for a distance of 288 metres in a westerly direction.
- (ii) From a point 720 metres west of its junction with the western kerb line of Soughley Lane for a distance of 210 metres in a westerly direction.
- (iii) From a point 1160 metres west of its junction with the western kerb line of Soughley Lane for a distance of 16 metres in a westerly direction.
- (iv) From a point 1224 metres west of its junction with the western kerb line of Soughley Lane for a distance of 182 metres in a westerly direction.

The south east and east side:

(i) From a point 1617 metres west of its junction with the western kerb line of Soughley Lane for a distance of 53 metres in a southerly direction.

The east side:

(i) From a point 1965 metres west and south of its junction with the western kerb line of Soughley Lane for a distance of 37 metres in a southerly direction.

2. This Order shall come into operation on the 15th day of August, 2022 and may be cited as The Sheffield City Council (Consolidation) (On-Street Parking and Prohibition of Waiting) (Outer Area) Order 2008 (Amendment No.152) Order 2022.
