- Prohibition of Waiting At Any Time on parts of Dobroyd Avenue, Hangthwaite Close, Harrington Road, Prince of Wales Road, Queen Mary Road, Redmires Road, Skipsea Road, Soughley Lane, Tickhill Drive, Travey Road and Tuffolds Close.
- No Waiting 8am to 6.30pm on part of Harrington Road;
- Pay and Display Parking Monday to Saturday 8am to 6.30pm, max stay 2 hours no return for 2 hours, on parts of Harrington Road;
- 20mph Speed Limit on the whole or parts of Ayton Close, Barden Close, Dobroyd Avenue, Elvaston Way, Hangthwaite Close, Mackworth Close, Queen Mary Road, Ravensworth Close, Riddings Close, Skellow Close, Skipsea Road, Tickhill Drive and Travey Road.


Princes Gardens 20mph SLO Plan


