NOTICE IS HEREBY GIVEN that the Sheffield City Council proposes to make an Order under the provisions of Sections 1, 2(1) to (3), 4(2), 32(1), 35(1), 45, 46, 46A, 49, 51, 53 and 124(1)(c), (d) (f) and Schedule 9 of the Road Traffic Regulation Act 1984.

The effect of the Order will be to introduce:

- Prohibition of Waiting At Any Time on parts of Barkers Pool, Black Swan Walk, Leopold Street, Pinstone Street and Surrey Street;
- Prohibition of Loading At Any Time on parts of Barkers Pool, High Street Southern Carriageway and Leopold Street;
- Prohibited Right-hand turn on part of Surrey Street;
- Prohibition of Vehicles on parts of Barkers Pool, Black Swan Walk, Exchange Gateway, Fargate, High Street, Leopold Street, Norfolk Row, Pinstone Street and Surrey Street;
- Permit Parking Bay on part of Barkers Pool;
- One Way Traffic on parts of Fargate, High Street, Norfolk Row and Surrey Street;
- Loading only bay on part of High Street Southern Carriageway;

And remove:

- Restriction of Loading Monday to Saturday 8:00am to 9:30am and 4:30pm to 6:30pm on parts of Barkers Pool and Leopold Street;
- Prohibition of Loading At Any Time on parts of High Street Southern Carriageway;
- Police Vehicle Parking Bay on part of Barkers Pool;
- Loading only bay on part of High Street Southern Carriageway;
- Prohibition of Vehicles on parts of Exchange Gateway, Fargate and Norfolk Row;
- One Way Traffic on parts of Fargate and Norfolk Row.

## STATEMENT OF REASONS

## Future High Streets – Fargate

The proposed TROs compliment the new public realm scheme for Fargate. The enhanced public space incorporates raise and lower bollards that will only allow vehicles to access Fargate at certain times for loading/unloading (except for exemptions) and, together with the proposed extended one-way, will control vehicle movements within the newly defined public space. Proposed waiting and loading restrictions, loading only bays and permit only bays facilitate the movement of traffic, improve access and facilitate activities of businesses in the area.

- 1. The Sheffield City Council (Various Roads, Central Area) (Prohibition of Driving, Prescribed Turns and Prohibited Turns) Order 1992 (as amended) shall have effect as though:
  - a) In Schedule 4 thereto there was included the following item:
    - 13.Surrey StreetSouthSurrey Street
- 2. This Order shall come into operation on the day of , 2022 and may be cited as The Sheffield City Council (Various Roads, Central Area) (Prohibition of Driving, Prescribed Turns and Prohibited Turns) Order 1992 (Amendment No.) Order 2022.

The Sheffield City Council ("the Council") in exercise of its powers under Section 1(1), 2(1) to (3), 4 (2), 32(1), 35(1), 45, 46, 46A, 49, 51, 53 and 124 (1) (c) (d)and (f) of the Road Traffic Regulation Act 1984 (c.27) ("the Act") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby makes the following Order:-

1. This Order shall come into operation on the , 2022 and may be cited as The Sheffield City Council (Fargate Area, Sheffield) (Prohibition of Vehicles and One Way Traffic) Order 2022.

## Definitions

In this Order:-

"Permit" means a permit issued by the Council and used in a manner directed by the Council.

"Road" has the same meaning as that in section 142 of the Act.

"Traffic Sign" means a sign or marking of any size, colour and type prescribed or authorised under or having effect as though prescribed or authorised under Section 64 of the Act.

- 2. Save as provided in Articles 3 and 4and subject to the provisions of Article 5, no person shall cause or permit any vehicle, except upon the direction of with the consent of a police constable in uniform, to proceed in that area of Road confined by the boundary set out in the plan included within the Schedule to this Order.
- 3. Nothing in Article 1 shall render it unlawful for any vehicle to proceed in that area of Road confined by the boundary set out in the plan included within the Schedule to this Order if the vehicle is:-
  - (a) displaying a Permit issued by the City Council;
  - (b) being used in connection with any building operation, demolition or excavation in or adjacent to the said roads or the maintenance, improvement or reconstruction of the said roads or the laying, erection, alteration, removal or repair in or adjacent to the said roads of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity or of any telegraphic line or traffic sign if the vehicle cannot reasonably be used for that purpose in any other road;
  - (c) an official vehicle forming part of a wedding or funeral cortege.
  - (d) being used in an emergency for ambulance, fire brigade, police or local authority purposes.
- 4. Nothing in Article 2 shall render it unlawful for any vehicle to proceed in the Roads referred to therein between midnight to 10 a.m. and 6.00 p.m to midnight, if:
  - i) that vehicle is taking access for the purposes of loading or unloading at premises; and
  - ii) the Council has not authorised the carrying out of a sporting event, social event or entertainment on the Roads and access has been restricted, said restriction

being indicated by the display of Traffic Signs at such times as authorised by the City Council for reasons of public safety prior to, during and after those events.

- 5. Any motor vehicle proceeding in the following roads of parts of roads subject to the provision of Articles 3 and 4 of this Order shall proceed in the direction specified in relation to that road or part of that road:-
  - (a) Fargate, between High Street and Surrey Street Southwest bound;
  - (b) Norfolk Row Southeast bound;
  - (c) Surrey Street that area of land bounded by its junction with Fargate to a point 20 metres in a south easterly direction Southeast bound;
  - (d) High Street Between Black Swan Walk and a point 28 metres north of Black Swan Walk Southwest bound.
- 6. The Sheffield City Council (Exchange Gateway, Fargate and Norfolk Row) (Prohibition of Driving) Order 1997 is hereby revoked.
- 7. This Order shall come into operation on the , 2022 and may be cited as The Sheffield City Council (Fargate Area, Sheffield) (Prohibition of Vehicles and One Way Traffic) Order 2022.



The Sheffield City Council(hereinafter referred to as "the Council") under Sections 1, 2(1) to (3), 4(2), 32(1), 35(1), 45, 46, 46A, 49, 51, 53 and 124(1)(c), (d) and (f) of the Road Traffic Regulation Act 1984 (c.27) ("the Act") and of all other enabling powers, and after consulting the Chief Officer of Police in accordance with Part 111 of Schedule 9 to the Act, hereby make the following Order:-

- 1. The Sheffield City Council (On-Street Parking and Prohibition of Waiting) (City Centre Controlled Zone Parking Zone) Order 2008 (as amended) shall have effect as though:
  - a) In Article 2 thereto there was substituted the following item:-

"Parking Place" means an area of carriageway described in the Schedules listed in Table 2, Table 2A, Table 3, Table 4 and Table 5 or in the Schedules 8.02, 10 and 10A to this Order and which is authorised to be used as a parking place by Article 1 of Sections A, B, C, D, F, G and H of Part III of this Order.

b) In Part III Parking Places and Bays thereto was included the following items:-

Section H: Permit and Voucher Parking

- (a) Each of the roads specified in the Schedules listed in Column 1 of Table 5 to this Order may be used, subject to the provisions of this Order, as a parking place during the days and hours listed in Column 2 of that table relating to that Schedule if the vehicle is displaying a Parking Permit issued by the City Council with respect to that vehicle and which is being used in a manner directed by the City Council.
  - (b) Nothing in paragraph (a) of this Article shall restrict the power of the Council to close any parking place.
- 2) If a vehicle is left in any parking place in a Schedule listed in Column 1 of Table 5 other than as provided for in Article 3 of this Section of this Order, it shall be a contravention of this Order.
- No person shall cause or permit any vehicle to wait in any Permit Parking Bay if the Council has suspended use of the Permit Parking Bay or part thereof;
- 4) The driver of the vehicle using the Permit Parking Bay :-
  - (a) Shall park wholly within the limits of the Permit Parking Bay.

- (b) Shall stop the engine as soon as the vehicle is in position in the bay and shall not start the engine except when about to change position of the vehicle in, or to depart from, the bay.
- 5) Exemptions

Without prejudice to the foregoing provisions of this Section with respect to vehicles which are left in a Parking Place in accordance with those provisions, any vehicle may wait in a Parking Place, other than a Parking Place or part of a Parking Place which has been suspended, described in any Schedule listed in Table 5 to this Order during the days and times listed in Column 2 of Table 5 relating to that Parking Place,

- 1. The vehicle is waiting only for so long as is necessary to enable a person to board or alight from the vehicle;
- 2. The vehicle is waiting owing to the driver being prevented from proceeding by circumstances beyond his control or to such waiting being necessary in order to avoid an accident;
- 3. The vehicle is being used in an emergency by the fire brigade, ambulance or local authority purposes.
- 4. The vehicle is being used for operational purposes by the Police
- 6) <u>Suspension of Permit Parking Bays</u>
  - (a) The Council may suspend the use of a Permit Parking Bays, or any part thereof, if such suspension is deemed to be reasonably necessary:-
    - (i) For the purpose of facilitating the movement of traffic or promoting its safety;
    - (ii) For the purpose of any building operation, demolition or excavation in or adjacent to the bay;
    - (iii) For the convenience of occupiers of premises adjacent to the bay for the removal or delivering of furniture or goods or at times of weddings or funerals or on other special occasions.
- 7) (a) Any person suspending the use of a Permit Parking Bay or any part thereof, shall place or cause to be placed a traffic sign in or adjacent to the bay, indicating that the bay is suspended.
- 8) <u>Removal of Vehicles</u>

When a vehicle is left in a Permit Parking Bay in contravention of any of the provisions of this Section the Council may arrange for that vehicle to be moved or removed and may do so in any manner considered necessary and shall make such arrangements as may be reasonably necessary for the safe custody of the vehicle.

9) Display of Parking Permit

The driver of a vehicle left in a Parking Place specified in the Schedules listed in Column 1 of Table 5 to this Order shall display or cause to be displayed in that vehicle a valid Permit issued by the Council, for a charge to be determined by the Council and used in the manner directed by the Council:-

(i) at all times during which the vehicle is left during the operative hours in the parking place;

- (ii) to the front or near side of the vehicle; and
- (iii) so that all details on the parking permit are readily visible from the front or nearside of the vehicle.
