The effect of the Order will be to introduce:

- Prohibition of waiting at any time on parts of Abbeydale Road and Wolseley Road;
- No loading at any time on part of Abbeydale Road, Broadfield Road left turn slip lane and Wolseley Road;
- Prohibited right hand turn on part of London Road Access Road opposite No.465 London Road;

And remove:

- Restriction of waiting and loading Monday to Friday 7.30am to 9.30am and 4.00pm to 6.30pm on parts of Abbeydale Road and Wolseley Road.

Notice is hereby given that Sheffield City Council in exercise of its powers under Section 90A of

the Act, intends to install A road hump as below:

1 Speed plateaux, kerb to kerb, 75mm high and 16 metres long at the following location:-

• **WOLSELEY ROAD** - From its junction with the south eastern kerb line of Abbeydale Road for a distance of 16 metres in an easterly direction.

This measure is aimed at controlling speed and improving visibility for a crossing point on Wolseley Road.

STATEMENT OF REASONS

Abbeydale Road and Wolseley Road

Changes to Waiting and Loading Restrictions in and around the junctions is proposed to improve road safety. A road plateau is also proposed to reduce the speed of traffic turning into Wolseley Road from Abbeydale Road. SD-2126-TRO 1

London Road Access Road opposite No.465 London Road – No Right Hand Turn

A 'No Right Hand Turn' is proposed from the new access road for a development plot off London Road. The right-hand turn has been identified as a potential road safety issue.

SD-2047-TRO 2

Broadfield Road – left turn slip road – No loading at any time

'No Loading At Any Time' is proposed for the new left turn slip road out of Broadfield Road to ensure the free flow of traffic onto London Road at all times. SD-2047-TRO 2






