The Sheffield City Council in exercise of its powers under Sections 1, 2(1) to (3), 4(2), 32(1), 35(1), 45, 46, 46A, 49, 51, 53 and 124(1)(c), (d) and (f) of the Road Traffic Regulation Act 1984 (c.27) ("the Act") and of all other enabling powers, and after consulting the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order:-

- The Sheffield City Council (Consolidation) (On-Street Parking And Prohibition Of Waiting) (City Centre Controlled Parking Zone) Order 2008 (as amended) shall have effect as though:
 - c) In Schedule 14.01 thereto there were included the following items:-

Arundel Gate

The east side:

- (i) The whole of the footway or verge from a point 33 metres south of the projected north facing building line of the Lyceum Theatre for a distance of 54 metres in a southerly direction.
- (ii) The whole of the footway or verge from a point 10 metres south of the projected south western building line of no.40 Castle Square for a distance of 74 metres in a southerly direction.

The south east side:

(i) The whole of the footway or verge from a point 19 metres north east of the projected north eastern kerb line of Charles Street for a distance of 65 metres in a south westerly direction.

Bakers Hill

The north west side:

(i) The whole of the footway or verge from its south west termination for a distance of 10 metres in a north easterly direction.

Brook Drive

The south side:

(i) The whole of the footway or verge from a point 10 metres east of its junction with the eastern kerb line of St Georges Close for a distance of 35 metres in an easterly direction.

Charter Square

The south east side:

(i) The whole of the footway or verge from a point 32 metres north west of the projected north

western kerb line of Pinstone Street for a distance of 96 metres in a south westerly direction

Eyre Street

The south east side:

(ii) The whole of the footway or verge from a point 25 metres north east of its junction with the north eastern kerb line of Matilda Street to its junction with Furnival Square.

The north west side:

(ii) The whole of the footway or verge from a point 10 metres south west of its junction with the south western kerb line of Cumberland Street for a distance of 75 metres in a south westerly direction.

Furnival Gate

The north east side:

(i) From a point 16 metres north west of its junction with the north western kerb line of Union Street for a distance of 19 metres in a north westerly direction.

Furnival Square

The south east side:

(i) The whole of the footway or verge from its junction with Eyre Street for a distance of 11 metres in a north easterly direction.

Glossop Road

The north side:

(i) The whole of the footway or verge from a point 4.5 metres west of its junction with the western kerb line of Regent Terrace for a distance of 29 metres in a westerly direction.

High Street

The north west side:

(i) The whole of the footway or verge from a point 1 metre north east of its junction with the eastern kerb line of East Parade for a distance of 150 metres in a north easterly direction.

New Street

The west side:

(i) The whole of the footway or verge from its junction with West Bar for a distance of 30 metres in a southerly direction.

Norfolk Street

The north west side:

(ii) The whole of the footway or verge from a point 5 metres south west of its junction with the south western kerb line of George Street for a distance of 23 metres in a south westerly direction.

Shude Hill

The west side:

(i) The whole of the footway or verge from a point

19 metres south of its junction with the southern kerb line of Dixon Lane for a distance of 15 metres in a southerly direction.

Solly Street

The north side:

(i) The whole of the footway or verge from a point 83 metres north east of its junction with the north eastern kerb line of Brocco Street for a distance of 65 metres in a north easterly direction.

Upper Allen Street

The north west side:

- (i) The whole of the footway or verge from a point 4 metres north east of its junction with the north eastern kerb line of Well Meadow Drive for a distance of 47 metres in a north easterly direction.
- (ii) The whole of the footway or verge from a point 15 metres north east of its junction with the north eastern kerb line of Brook Drive for a distance of 85 metres in a north easterly direction.

Wicker

The south east side:

(i) The whole of the footway or verge from a point 20 metres south west of its junction with the south western kerb line of Windrush Way for a distance of 71 metres in a south westerly direction.

The north west side:

- (i) The whole of the footway or verge from a point 4 metres north east of its junction with the north eastern kerb line of Stanley Street for a distance of 38 metres in a north easterly direction.
- 2. This Order shall come into operation on the 24th day of July 2023 and may be cited as The Sheffield City Council (Consolidation) (On-Street Parking And Prohibition Of Waiting) (City Centre Controlled Parking Zone) Order 2008 (Amendment No.49) Order 2023.
