## **IMPORTANT INFORMATION**

Providers are free to choose which weeks they offer FEL and if they wish follow the same 39 weeks delivery pattern that Sheffield schools are open.

Please refer to School holidays and term dates

but please note, for the autumn term providers will need to choose one week they don't offer FEL.

Providers can distribute 38 FEL weeks in a different pattern over the year to the suggested FEL funding periods. A Variation to Standard Weeks Form which can be found online at <a href="Information for FEL Providers">Information for FEL Providers</a> needs to be submitted.

Providers can offer FEL over more than 38 weeks, the "Stretched Offer" on the Headcount information needs to be ticked and the claim adjusted accordingly.

The Local Authority will monitor all FEL Children's Entitlement on a termly basis. Please refer to Claims for excess hours in the Code of Practice.
