### **Definitions**

Funded Early Learning (FEL) - This is the 15 funded hours for all 3 and 4 year olds and disadvantaged 2 year olds. Children are eligible the term after their 3<sup>rd</sup> birthday, or 2<sup>nd</sup> birthday if they are eligible.

Extended Funded Entitlement (EFE) – This is the extra 15 funded hours working families are entitled to. This will include the new entitlement for 2 year olds from April 2024 and 9 months to 1 year olds from September 2024.

Entitlements Expansion (EE) – This is the new initiative for working families. The expansion is to be introduced in 3 phases;

- Phase 1: April 2024 15 hours of childcare over 38 weeks of the year made available to eligible parents of two-year-olds.
- Phase 2: September 2024 15 hours of childcare over 38 weeks of the year made available to eligible parents of 9-month to 36-montholds.
- Phase 3: September 2025 30 hours of childcare over 38 weeks of the year made available to eligible parents of 9-month to 36-montholds



# Planning Area 1 - FEL Performance Profile for 2 Year Olds - Spring 2023





Take-up of places in Spring 2022/23 is not that dissimilar to the rates of take-up seen in Spring 2020/21, and encouragingly in Planning Area 1 South take-up rates have actually improved. Fluctuations in take-up can in part be attributed to take-up not being compulsory and families having varying requirements for the number of hours and some elements of Funded Early Learning are subject to eligibility criteria. Parents can choose between a vast number of Early Years providers, from Childminders to Private and School nursery settings and they also seek places outside their local area, nearer to other family members or nearer/enroute to work. This can have a considerable impact on the sufficiency of places in a given area.

Take-up rates in the North and South of the Planning Area are not dissimilar and have remained fairly consistent since Spring 2021. Encouragingly Spring 2022/23 data reflects slight improvements in take-up as compared to take-up rates in Spring 2020/21. There are generally sufficient places for all 3-&-4-year-olds who wish to access a funded place, so take up can be used as a good indicator of actual demand and take-up rates in Sheffield are not dissimilar to those reflected by the national picture.

The Local Authority continues to raise awareness of Funded Early Learning entitlements in areas of lower take-up, but it is also acknowledged that there are some cultural barriers to families accessing Funded Early Learning.




Map 1: Eligible 2 Year Olds not Taking-up FEL

Eligible Two Year Olds Not Taking-up a FEL Place in Planning Area 1 - Spring 2023




# Map 2: All 3 and 4 Year Olds not Taking-up FEL or Early Education


All Three and Four Year Olds Not Taking-up FEL in Planning Area 1 - Spring 2023




Map 3: EFE Take-up
