#### **Definitions**

Funded Early Learning (FEL) - This is the 15 funded hours for all 3 and 4 year olds and disadvantaged 2 year olds. Children are eligible the term after their 3<sup>rd</sup> birthday, or 2<sup>nd</sup> birthday if they are eligible.

Extended Funded Entitlement (EFE) – This is the extra 15 funded hours working families are entitled to. This will include the new entitlement for 2 year olds from April 2024 and 9 months to 1 year olds from September 2024.

Entitlements Expansion (EE) – This is the new initiative for working families. The expansion is to be introduced in 3 phases;

- Phase 1: April 2024 15 hours of childcare over 38 weeks of the year made available to eligible parents of two-year-olds.
- Phase 2: September 2024 15 hours of childcare over 38 weeks of the year made available to eligible parents of 9-month to 36-montholds.
- Phase 3: September 2025 30 hours of childcare over 38 weeks of the year made available to eligible parents of 9-month to 36-montholds.



# Planning Area 6 - FEL Performance Profile for 2 Year Olds - Spring 2023





Take-up of 2 year old FEL shows a mixed picture in Planning Area 6. Whereas take-up has increase between 2021 and 2023 in the North, it has fallen in the South. There are 4 LSOAs where 5 or more eligible children are not taking up FEL. All of these are in the North which appears to contradict the statement above, but this is because the eligible population here is much larger than the South. There are sufficient FEL places in the Planning Area at the current level of take-up. However, these are not distributed evenly, with there being a greater number of places in the North.

Over the last 3 years take-up in the North has been consistent whilst in the South it has dipped very slightly. There are 14 LSOAs in the Planning Area that have 5 or more eligible children not taking up FEL. These are evenly distributed between the North and South. Overall, there are sufficient FEL places in the Planning Area. There is a slight shortfall of places in the South, but this is more than compensated for by the oversupply of places in the North.




Map 1: Eligible 2 Year Olds not Taking-up FEL

Eligible Two Year Olds Not Taking-up a FEL Place in Planning Area 6 - Spring 2023




Map 2: All 3 and 4 Year Olds not Taking-up FEL or Early Education

All Three and Four Year Olds Not Taking-up FEL in Planning Area 6 - Spring 2023




Map 3: EFE Take-up
