Definitions

Funded Early Learning (FEL) - This is the 15 funded hours for all 3 and 4 year olds and disadvantaged 2 year olds. Children are eligible the term after their 3rd birthday, or 2nd birthday if they are eligible.

Extended Funded Entitlement (EFE) – This is the extra 15 funded hours working families are entitled to. This will include the new entitlement for 2 year olds from April 2024 and 9 months to 1 year olds from September 2024.

Entitlements Expansion (EE) – This is the new initiative for working families. The expansion is to be introduced in 3 phases;

- Phase 1: April 2024 - 15 hours of childcare over 38 weeks of the year made available to eligible parents of two-year-olds.
- Phase 2: September 2024 - 15 hours of childcare over 38 weeks of the year made available to eligible parents of 9-month to 36-month-olds.
- Phase 3: September 2025 - 30 hours of childcare over 38 weeks of the year made available to eligible parents of 9-month to 36-month-olds.

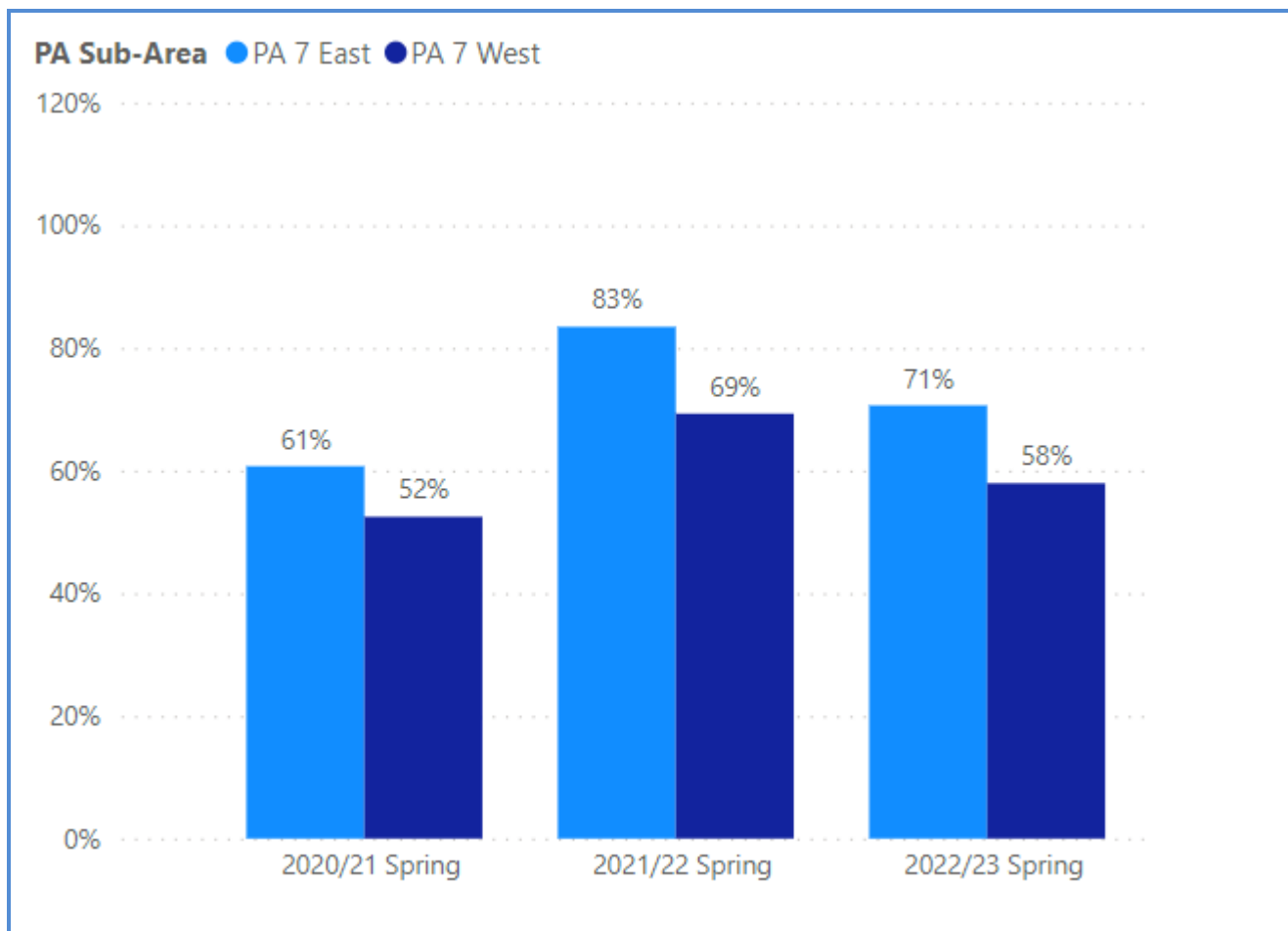

Wraparound Data – January School Census 2023. Although several surveys have been carried out to collect more up to date data, there has been a mixed response and only about 50% schools have responded. This information is therefore incomplete and has meant we have used 2023 School Census as it gives us a more complete picture.

Planning Area 7 - FEL Performance Profile for 2 Year Olds – Spring 2023



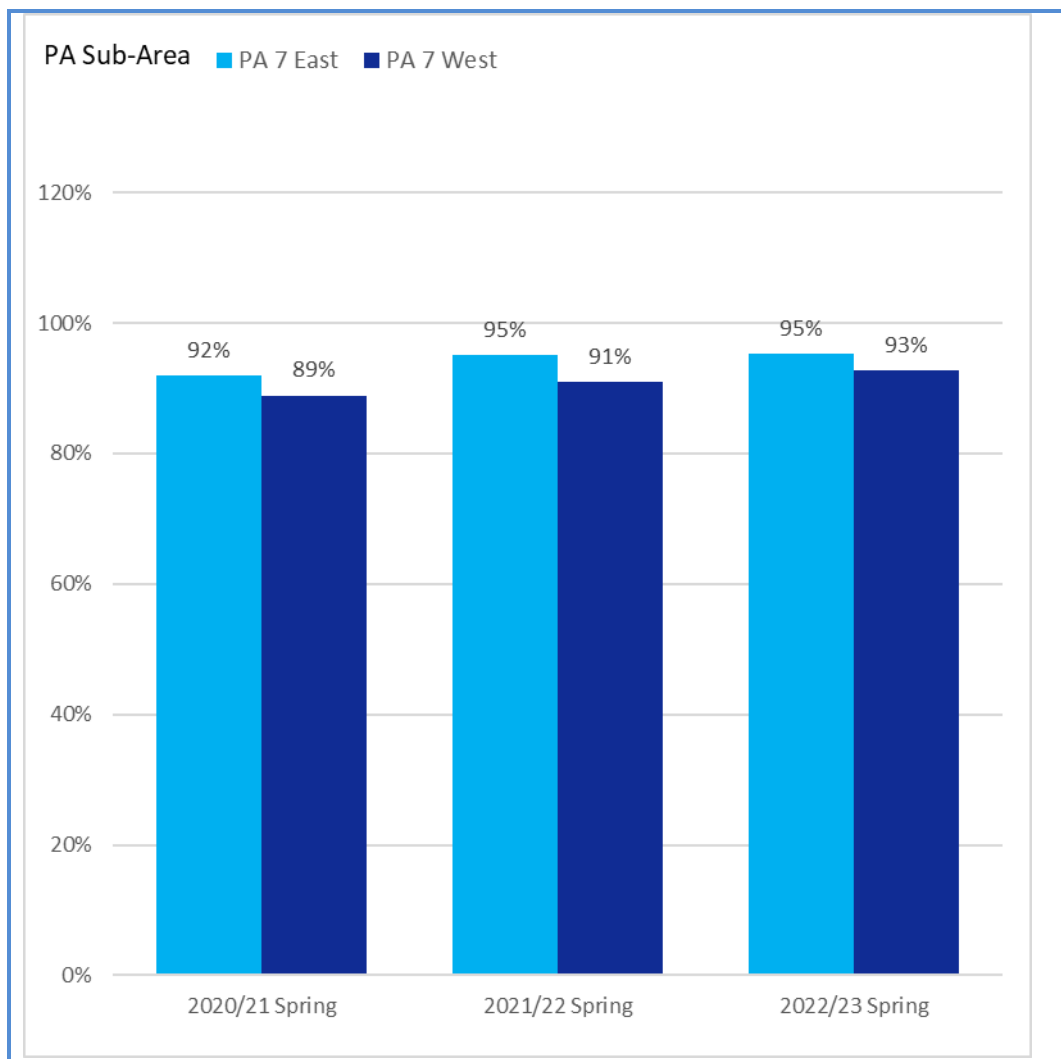

*LSOAs are ranked in terms of their deprivation according to IDAC1 (IMD 2019). LSOAs ranked 1 are within the 10% most deprived LSOAs in the country. Those with a rank of 2 are between the 10% and 20% most deprived. The ranking goes to 10 which indicated the 10% least deprived LSOAs.

Between 2021 and 2023 take-up of 2 Year old FEL has increased in both sub-areas. The level in the East is roughly in line with the City average, whilst in the West it is quite a bit below. 7 LSOAs have 5 or more eligible children not claiming FEL, the majority in the West. There are currently insufficient FEL places in the Planning Area, although some of the children may attend a setting in a neighbouring Planning Area where there are more places.

There has been a slight increase in the take-up of FEL in both sub-areas. The East has a slightly higher take-up, though the greatest increase has been in the West. There are 13 LSOAs where 5 or more children are not taking up FEL, although only 1 where more than 10 are not taking up their offer. The majority are in the West. There are currently insufficient FEL places for 3 and 4 year olds. As with the 2 year olds, children are likely to take up their place in a neighbouring Planning Area where there are more than sufficient places.

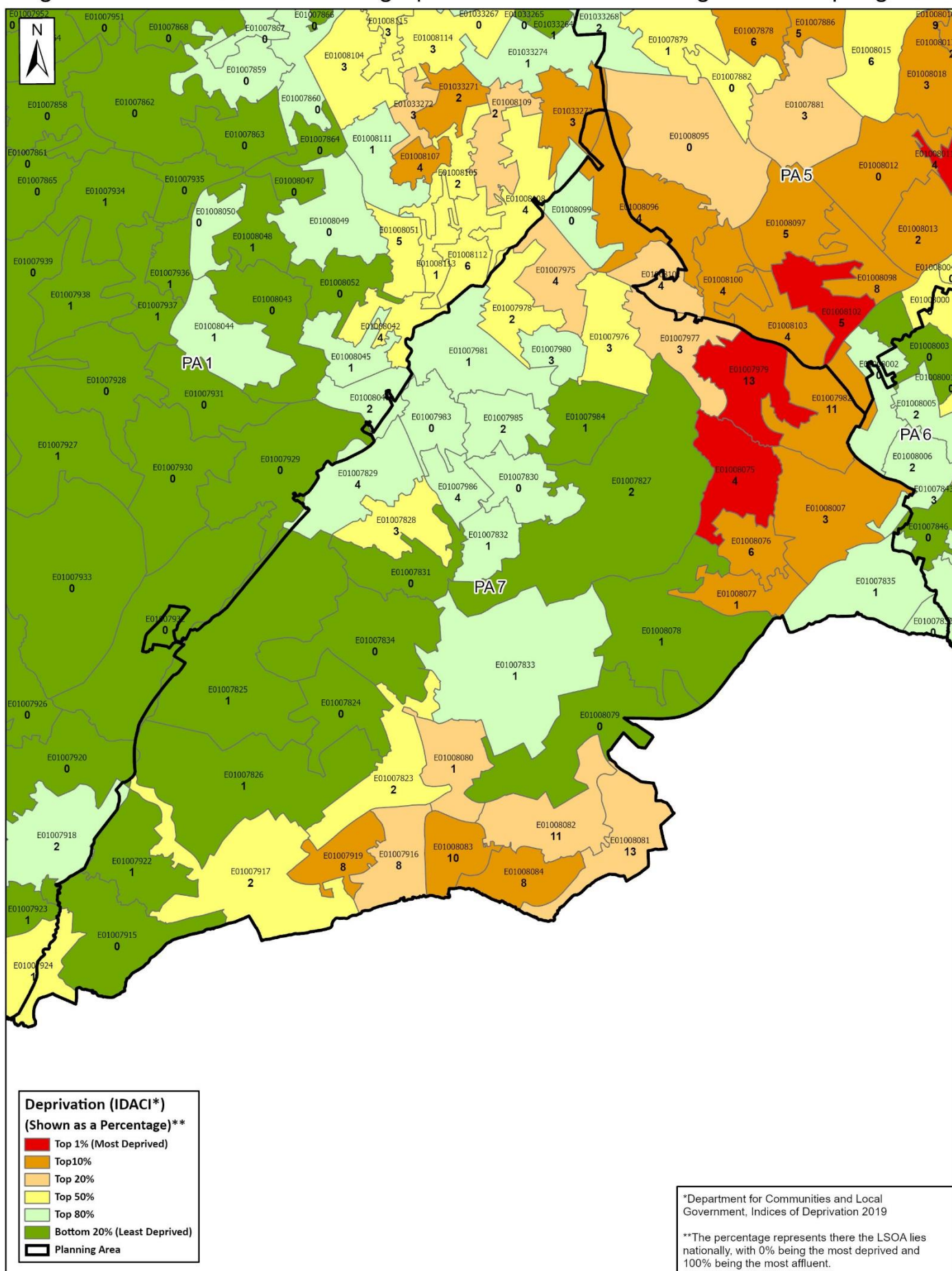

Like the EFE, the new EE is only available to working families. Both parents, or a single parent, have to be working the equivalent of 16hrs on the minimum wage. The data above may give some indication on the level of demand. It is also expected the greatest demand for wraparound care will come from working parents.

Eligible Two Year Olds Not Taking-up a FEL Place in Planning Area 7 - Spring 2023

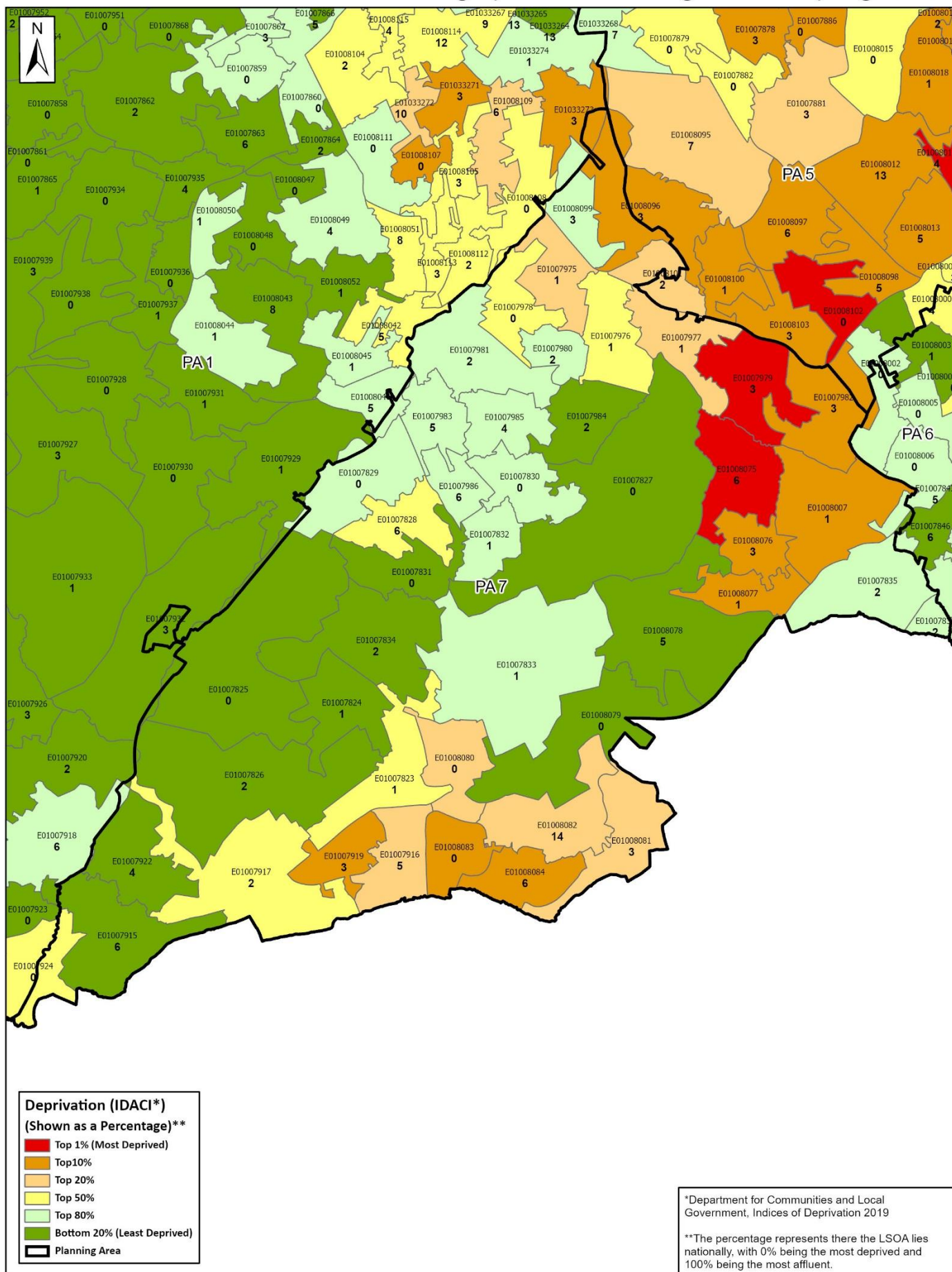

All Three and Four Year Olds Not Taking-up FEL in Planning Area 7 - Spring 2023

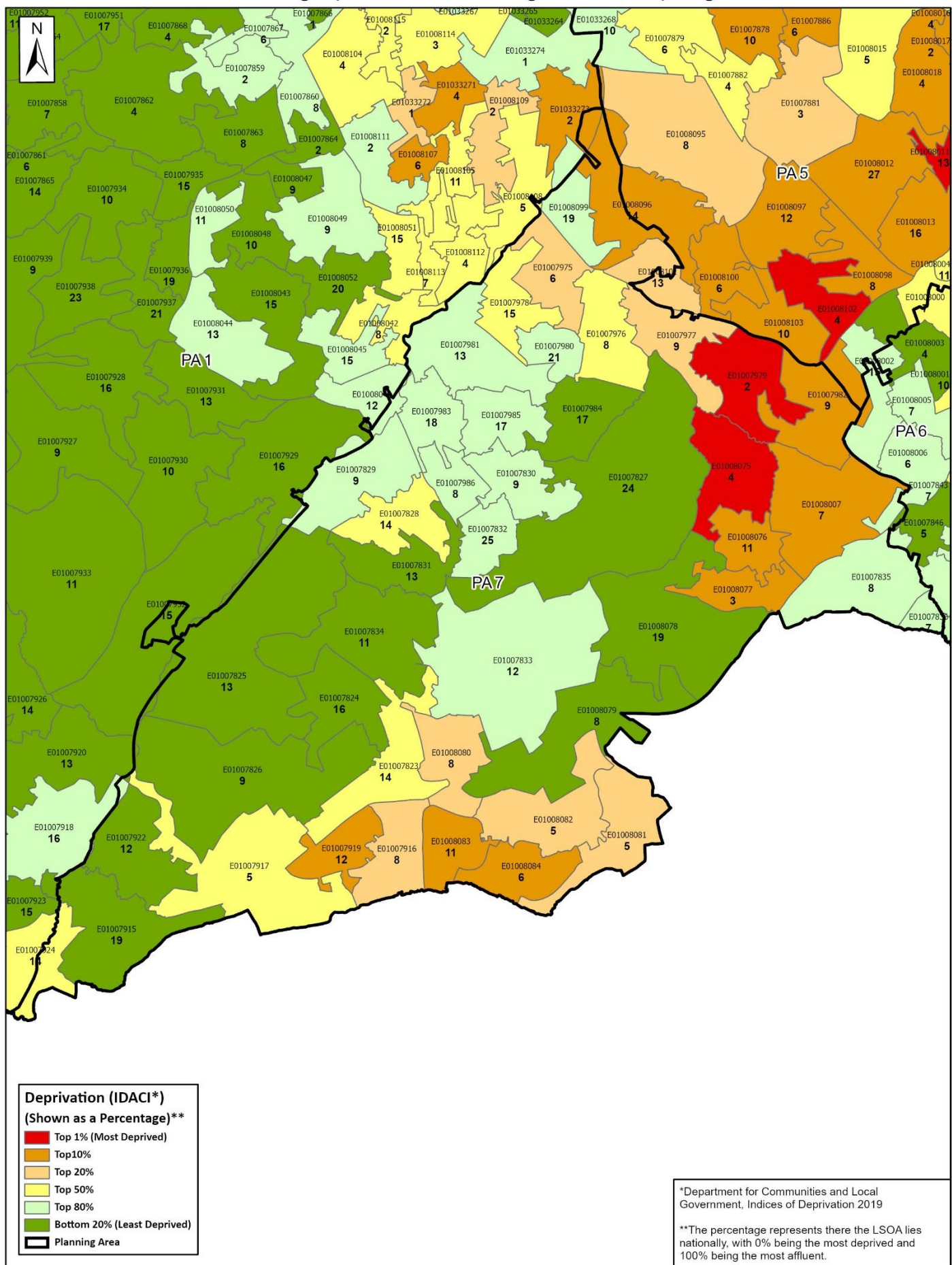

Number of Children Taking-up EFE in Planning Area 7 - Spring 2023

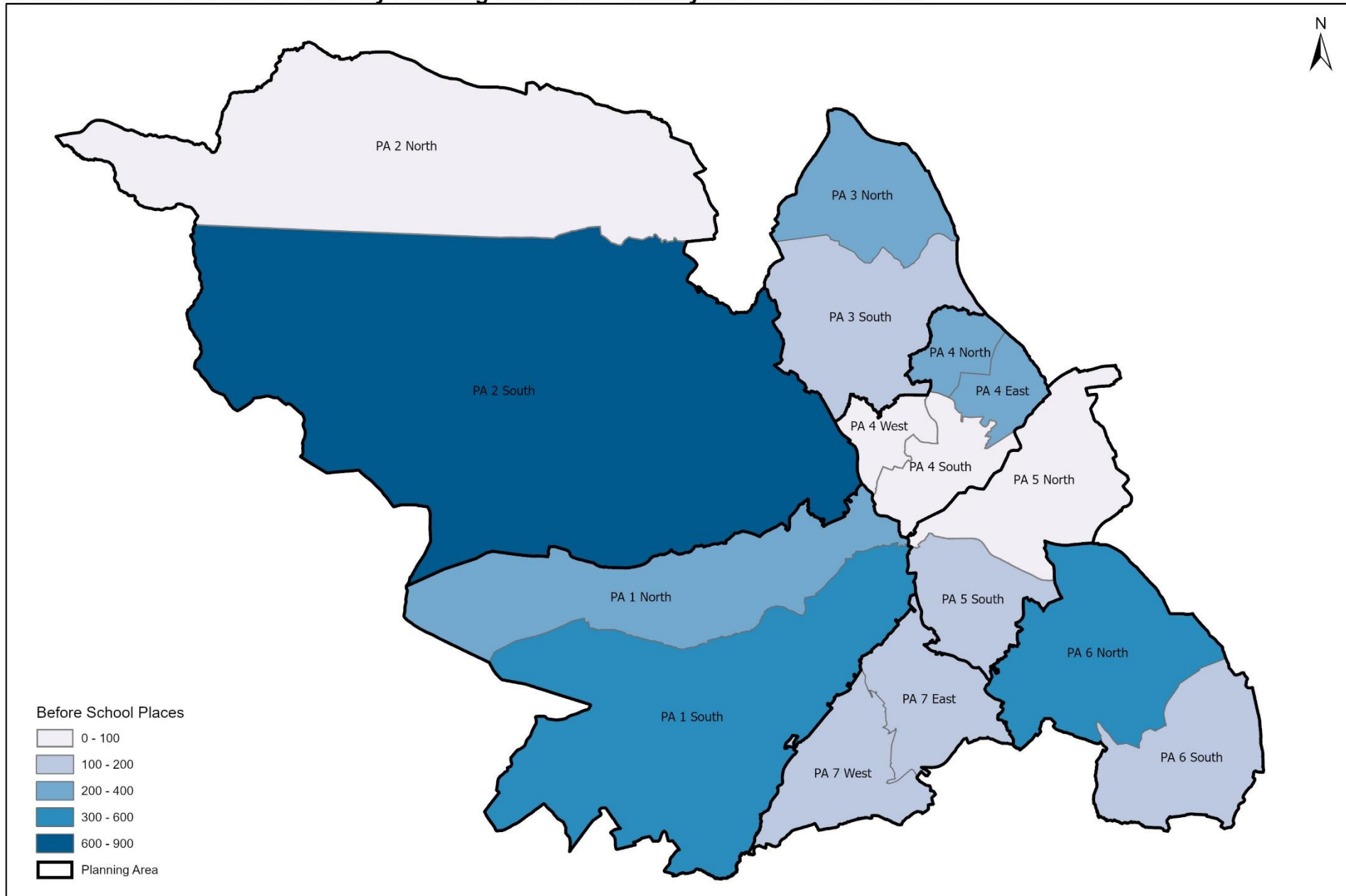

Number of Before School Places by Planning Sub-Area - January 2023 School Census

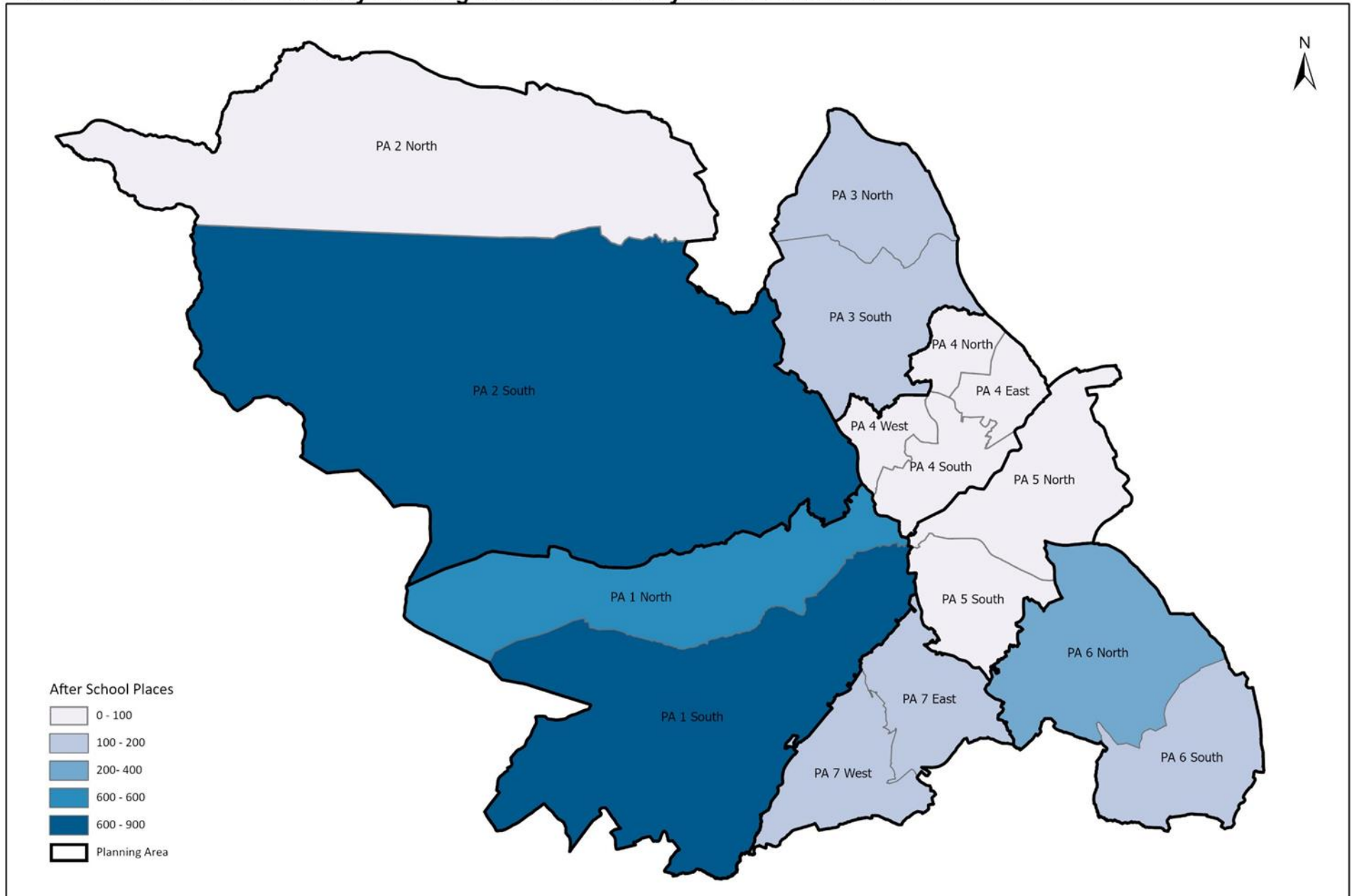
