- No Waiting at any time on Fitzwilliam Street and Gilpin Lane

And remove:

- Paid for Parking Place on Fitzwilliam Street

1. The Sheffield City Council (Stopping Restrictions, Waiting Restrictions, Loading Restrictions and Parking Places)(Map Schedule) Order 2024 (as amended) is varied as provided by the following plans attached to Schedule 1 in this Order.
