The effect of the Order will be to introduce:

- No waiting at any time on part of Olive Grove Road

And remove

- No waiting Monday to Saturday 08:00 to 18:30 on part of Olive Grove Road

The Authority's reasons for proposing to make the above named Order(s) are as follows:-

- For avoiding danger to persons or other traffic using the road or any other road or for preventing the likelihood of any such danger arising, or
- For facilitating the passage on the road or any other road of any class of traffic (including pedestrians)

Explanatory Note:-

Olive Grove Road - the proposed no waiting at any time double yellow line restrictions and removal of No Waiting Monday to Saturday 08:00 to 18:30 will protect the widened vehicular access for staff and visitors to the Olive Grove Rd Depot as part of a planning condition for the site improvements. These are required to facilitate improved access, visibility and safety for all road users at the access.
