NOTICE IS HEREBY GIVEN that on the 5th day of June 2025 the Sheffield City Council made the above Order which come into operation on the 9th day of June 2025 under the provisions of the Road Traffic Regulation Act 1984.

The effect of the Order will be to introduce:

- No Waiting at any Time on parts of Cemetery Avenue and Stalker Lees Road;
- No Waiting Monday to Saturday 08.00 to 18.30 on parts of Stalker Lees Road;
- Paid for Parking Places max stay 4 hours and Permit Holders Parking Place Monday to Saturday 08.00 to 18.30 on parts of Stalker Lees Road;
- Disabled Persons' Badge Holders Parking Places max stay 4 hours no return 4 hours on parts of Cemetery Avenue.

And remove:

- No Waiting at any time on Cemetery Avenue and Stalker Lees Road;
- Paid for Parking Places max stay 4 hours no return 4 hours and Permit Holders Parking Place Monday to Saturday 08.00 to 18.30 on parts of Stalker Lees Road;
- Paid for Parking Places max stay 2 hours and Permit Holders Parking Place Monday to Saturday 08.00 to 18.30 on parts of Cemetery Avenue;
