STATEMENT OF REASONS

The Authority's reasons for proposing to make the above named Order(s) are as follows:-

- For avoiding danger to persons or other traffic using the road or any other road or for preventing the likelihood of any such danger arising, or
- For facilitating the passage on the road or any other road of any class of traffic (including pedestrians), or
- For preserving or improving the amenities of the area through which the road runs

Explanatory Note:-

Ballifield Avenue and Handsworth Grange Road - The proposed no waiting at any time restriction is required to prevent obstructive parking occurring at unsuitable locations and to improve visibility, access and safety at the junction for all road users.

Church Lane and Delves Road, Hackenthorpe – The proposed no waiting at any time restriction is required to facilitate the movement of traffic and improve visibility and safety at the junction for all road users.

Colley Road and High Greave - The proposed no waiting at any time restriction is required to prevent obstructive parking occurring at unsuitable locations and to improve visibility, access and safety at road junction for all road users.

Ecclesfield Road and Deep Lane - The proposed no waiting at any time restriction and removal of No Waiting Monday to Saturday 8am to 6.30pm restriction is required to prevent obstructive parking occurring at unsuitable locations, on the footway and on the cycleway and to improve safety, access and visibility for all road users including vehicles accessing the nearby commercial premises.

Grimesthorpe Road, Botham Street, Cyclops Street, Petre Drive, Petre Street, Hunsley Street and Wood Spring Court - The proposed no waiting at any time restriction is required to prevent obstructive parking occurring at unsuitable locations in the area and to improve safety, access and visibility for all road users especially vehicles accessing the nearby commercial premises.

Norton Lane and Norton Church Road - The proposed no waiting at any time restriction is required to prevent obstructive parking occurring at unsuitable locations in the vicinity of the adjacent parkland and to improve visibility, access and safety at road junction for all road users.

Oak Street and Well Road - The proposed no waiting at any time restriction is required to prevent obstructive parking occurring at unsuitable locations and to improve visibility, access and safety at road junction for all road users and pedestrians crossing between adjacent green spaces and play areas.

Orgreave Drive - The proposed no waiting at any time restriction is required to facilitate improved access to commercial units and to improve access, safety and visibility for all road users.

Ringinglow Road and Ringinglow Close - The proposed no waiting at any time restriction is required to facilitate the movement of traffic for all road users in the vicinity of Bents Green School and to improve visibility, safety and access at Ringinglow Close.

Thornbridge Avenue and Thornbridge Place— The proposed no waiting at any time restriction is required to facilitate the movement of traffic outside Birley Primary Academy and to improve visibility, access and safetyfor all road users especially at busy times.

Thorncliffe Road - The proposed no waiting at any time restriction is required to facilitate improved access to adjacent Industrial Estate and to improve access, safety and visibility at the junction of Churchill Way and Thorncilffe Road.

Uppergate Road and Bankfield Lane – The proposed no waiting at any time restriction is required to facilitate the movement of traffic and improve access, safety and visibility at the nearby junctions for all road users.

Wheata Place and Wheata Road - The proposed no waiting at any time restriction is required to prevent obstructive parking occurring at unsuitable locations and to improve visibility, access and safety at junction for all road users.

Harvey Clough Road and Woodland Road – The proposed no waiting at any time restriction is required to facilitate the movement of traffic and improve visibility and safety at the junction for all road users.
