MODIFICATION ORDER (No. 86) 2025

This Order is made by Sheffield City Council under Section 53(2)(a) and (b) of the Wildlife and Countryside Act 1981 ("the Act") because it appears to that authority that the Definitive Map and Statement (Stocksbridge) require modification in consequence of the occurrence of an event specified in Section 53(3)(c)(i) of the Act, namely, the discovery by the authority of evidence which (when considered with all other relevant evidence available to it) shows that a right of way which is not shown in the Map and Statement subsists or is reasonably alleged to subsist over land in the area to which the map relates, being a right of way to which Part III of the Act applies.

The authority has consulted with every local authority whose area includes the land to which the Order relates.

The Sheffield City Council hereby orders that:

1. For the purposes of this Order the relevant date is the 24th June 2025.
2. The Definitive Map and Statement (Stocksbridge, Sheffield) shall be modified as described in Part I and Part II of the Schedule and shown on the Maps attached to this Order.
3. This Order shall take effect on the date it is confirmed and may be cited as The Sheffield City Council (Definitive Map and Statement) Modification Order (No. 86) 2025.


