## Report purpose

This report seeks Board feedback on the draft scope of a proposed 'Gleadless Valley Plan for Renewal', to be produced in time for the Board's meeting in November 2025. The document will summarise the results of the masterplan refresh and set out a roadmap for securing additional investment and delivering the proposals.

The Board is asked to discuss and provide any comments on the draft document outline.

#### Introduction

On 19<sup>th</sup> August 2024, the Council's Strategy and Resources Policy committee approved the development of an improved approach to regeneration in Gleadless Valley; the review and refresh of the masterplan proposals to reflect the new approach; and the development of a Delivery Plan to be brought to the appropriate Council Policy Committee for consideration and approval.

The review and refresh of the masterplan proposals is under way and the Board is regularly reviewing progress and providing feedback.

The next stage in the process will focus on converting the updated masterplan proposals into tangible projects, identifying delivery routes and funding required for each project and setting out target timescales and phasing.

It is proposed that the updated masterplan proposals are combined with these project details in a single document that summarises the new approach and sets out a programme of investable projects.

It is proposed that this document is called 'Gleadless Valley: A Plan for Renewal' or similar rather than being called a 'Delivery Plan'. This is because we don't want to raise unrealistic expectations



among the community that everything in the plan is funded and will definitely be delivered. Indeed, a key purpose of the plan is to support approaches to funders, investors and delivery partners.

The sections below set out the proposed purpose of the plan, the timescales for production and approval and a draft outline of the document structure and contents.

## **Renewal Plan Purpose**

The document will:

- 1. Represent a new chapter in the regeneration of Gleadless Valley, both a statement of the Board's scale of ambition for the valley and a tangible sign that the programme is moving from planning towards delivery.
- 2. Provide a summary of the new plans for Gleadless Valley across all workstreams including details of projects that are already in delivery, those that are fully funded and those that require further funding.
- 3. Provide residents with greater certainty on what is in and out of the regeneration programme, and projects that they will be able to shape.
- 4. Act as a prospectus for investors and potential partners and a key supporting document for funding applications and business cases.
- 5. Identify the funding ask of Sheffield City Council, approval for which will be sought alongside the council's approval of the plan.
- 6. Set out clearly to development partners the Board's objectives and priorities for key development sites.
- 7. Act as a roadmap for the work of the Gleadless Valley Delivery Team over the coming few years.
- 8. Supersede the existing Gleadless Valley Masterplan (although it will integrate and build on some elements of the masterplan).
- 9. Be formally endorsed by the Gleadless Valley Regeneration Board and Sheffield City Council as the main landowner and lead delivery organisation.

### **Timescales**

Indicative timescales for approval of the Renewal Plan document are as follows:

Review by Gleadless Valley Delivery Group	Early November 2025
Review and approval by Gleadless Valley Regeneration Board	13 <sup>th</sup> November 2025
Review and approval by Sheffield City Council Strategy and Resources Committee	January 2026

These timescales are challenging and are subject to timely Board approval of the various proposals across different workstreams that the Board will be asked to review over the remainder of this calendar year.



#### **Draft document structure and contents**

It is proposed that the plan is drafted by the Gleadless Valley Regeneration Team. It is likely to come to Board initially as a draft produced in Microsoft Word with a fully designed version to be produced after approval.

After approval, one or more summary versions will also be produced as required for different audiences (residents, investors, etc.)

A draft outline of the proposed structure and contents of the document is set out below for Board comments.
