Appeals against the Rateable Value.

The Valuation Office Agency of the Inland Revenue assesses rateable values. Where a ratepayer considers the rateable value excessive or incorrect owing to physical alterations made to the property or changes in environmental factors adversely affecting the property; an appeal may be made to:
