Explanatory Note to Pollution Prevention and Control Permit for Part B Installations.

(This note does not form a part of the Permit)

The following Permit is issued under Regulation 13 of the Environmental Permitting (England and Wales) Regulations 2016, as amended (Statutory Instrument 1154), (“the EP Regulations”) to operate an installation carrying out activities covered by the description in section 3.1, Chapter 3 of Schedule 1 of those Regulations, to the extent authorised by the Permit:

Chapter 3, Mineral Industries, Section 3.1 Production of Cement and Lime

Part B (b) Blending cement in bulk or using cement in bulk other than at a construction site, including the bagging of cement and cement mixtures, the batching of ready-mixed concrete and the manufacture of concrete blocks and other cement products.

Process Changes

As part of your permit you are required to notify the Council of any proposed change in operation at least 14 days before making the change. This must be in writing and must contain a full description of the proposed change in operation and the likely consequences. Failure to do so is an offence.

If you consider that a proposed change could result in the breach of the existing permit conditions or is likely to require the variation of permit conditions then you may apply in writing under Regulation 20(1) of the EP Regulations. Additionally, if this involves a SUBSTANTIAL CHANGE to the installation you will be required to submit an application, pay the relevant fee and advertise the application accordingly. You may serve a Notice on the Council requesting that they determine whether any change that is proposed would constitute a substantial change before you proceed with application.

Variations to the Permit

The Permit may be varied in the future (by the Council serving a Variation Notice on the Operator). If the Operator itself wants any of the Conditions of the Permit to be changed, a formal Application must be submitted.

Surrender of the Permit

Where the operator of a Part B installation or mobile plant ceases or intends to cease the operation of the activity the operator may notify the regulator of the surrender of the whole permit, in any other case, notify the regulator of the surrender of the permit in so far as it authorises the operation of the installation or mobile plant which he/she has ceased or intends to cease operating. The notification shall contain information as described in Regulation 24 or 25 of the EP Regulations.

Transfer of the Permit or Part of the Permit

Before the Permit can be wholly or partially transferred to another person, a joint application to transfer the Permit has to be made by both the existing and proposed holders, in accordance with Regulation 21 of the EP Regulations. A transfer will be allowed unless Sheffield City Council considers that the proposed holder will not be the person who will have control over the operation of the installation or will not ensure compliance with the conditions of the transferred Permit.

Annual Subsistence Fee

In accordance with Regulation 66 of the EP Regulations, the holder of a permit is required to pay a fee for the subsistence of the Permit. This fee is payable annually on 1st April. You are advised that under the provisions of Regulation 66 (5) of the EP Regulations, if you fail to pay the fee due promptly, Sheffield City Council may revoke the Permit. You will be contacted separately each year in respect to this payment.

Public Register

The Council is required by Regulation 46 of the EP Regulations to maintain a Public Register containing information on all LAPPC installations and mobile plant. The register is available for inspection by the public free of charge during office hours (Monday to Friday 9.00 am to 5.00 pm) at the following address:

Confidentiality

Sheffield City Council has a duty to consider the question of confidentiality of information supplied to it. If any information supplied is considered confidential, a statement of which information this applies to and the reasons why it is considered confidential should be specified. The Operator is reminded that he may apply to Sheffield City Council for the exclusion of information from the public register under the provisions of the Environmental Permitting (England and Wales) Regulations 2016, as amended.

Appeals

Under Regulation 31 of the EP Regulations operators have the right of appeal against the conditions attached to their permit. Schedule 6 of the EP Regulations sets out the detailed procedures.

Appeals against a Variation Notice do not have the effect of suspending the operation of the Notice. Appeals do not have the effect of suspending Permit conditions.

Notice of appeal against the conditions attached to the permit must be given within six months of the date of the Notice, which is the subject matter of the appeal.

How to Appeal

There are no forms or charges for appealing. However, for an appeal to be valid, appellants (the person/operator making the appeal) are legally required to provide:

- Written notice of the appeal;
- A statement of the grounds of appeal;
- A statement indicating whether the appellant wishes the appeal to be dealt with by written representations procedure or a hearing - a hearing must be held if either the appellant or enforcing authority requests this, or if the Planning Inspector or the Secretary of State decides to hold one.
- (Appellants must copy the above three items to the local authority when the appeal is made)
- A copy of any relevant application;
- A copy of any relevant permit;
- A copy of any relevant correspondence between the appellant and the regulator; and
- A copy of any decision or notice, which is the subject matter of the appeal.

In the course of an Appeal process the main parties will be informed of procedural steps by the Planning Inspectorate.

To withdraw an appeal the appellant must notify the Planning Inspectorate in writing and copy the notification to the local authority.

Definitions

In relation to this Permit, the following expressions shall have the following meanings:

“Application” means the application for this Permit, together with any response to a notice served under Schedule 4 to the EPR Regulations and any operational change agreed under the conditions of this Permit.

“EPR Regulations” means the Environmental Permitting (England and Wales) Regulations S.I.2016 No. 1154 (as amended) and words and expressions defined in the EPR Regulations shall have the same meanings when used in this Permit save to the extent they are explicitly defined in this Permit.

“Permitted Installation” means the activities and the limits to those activities described in this Permit.

“Monitoring” includes the taking and analysis of samples, instrumental measurements (periodic and continual), calibrations, examinations, tests and surveys.

“Regulator” means any officer of Sheffield City Council who is authorised under section 108(1) of the Environment Act 1995 to exercise, in accordance with the terms of any such authorisation, any power specified in Section 108(1) of that Act.

“BAT” means the most effective and advanced stage in the development of activities and their methods of operation which indicates the practical suitability of particular techniques for providing in principle the bases for emission limit values designed to prevent, and where that is not practical, generally to reduce emissions and the impact on the environment as a whole. For those purposes:

“available techniques” means those techniques which have been developed on a scale which allows implementation in the relevant industrial sector, under economically and technically viable conditions, taking into consideration the cost and advantages, whether or not the techniques are used or produced inside the United Kingdom, as long as they are reasonably accessible to the Operator;

“best” means, in relation to techniques, the most effective in achieving a high general level of protection of the environment as a whole; *“techniques”* include both the technology used and the way in which the installation is designed, built, maintained, operated and decommissioned. Schedule 2 of the Regulations shall have effect in relation to the determination of best available techniques, and;

“Fugitive Emission” means an emission to air from the permitted installation that is not controlled by an emission limit imposed by a condition of this Permit.

Description of Activities

The batching of ready mixed concrete within a dry mix batching plant incorporating three aggregate storage bins and two storage silos, one with 50 tonne capacity, the other with 40 tonne capacity, each served by WAM reverse jet filters. One silo contains OPC Ordinary Portland Cement, the other GGBF Ground Granulated Blast Furnace Slag.

The Permit covers all associated processes such as the delivery, storage and handling of cement and aggregates, loading of truckmixers and the dispatch of waste and final products within the installation boundary marked in red as shown in Schedule 2 of this Permit, when the plant is based in Sheffield at Coleford Road.

The plant will initially be based at Coleford Road in Sheffield and also be mobile and operate elsewhere.

Conditions of Permit

Section 1 – Notifications

- 1.1 The operator shall, at least 7 days before the mobile plant is operated away from 299a Coleford Road, notify the Local Authority of the site where the mobile plant is to be operated, and also notify Sheffield City Council's Environmental Protection Service where and when the mobile plant is expected to start operating, and the plant to be involved. The form in Schedule 4 of this permit can be used as a template.

Section 2 – Emissions and Monitoring

- 2.1 No visible particulate matter shall be emitted beyond the installation boundary where the plant is operated.
- 2.2 The operator shall keep records of inspections, test and monitoring, including all non-continuous monitoring, inspections and visual assessment. Records shall be:
- Kept on site;
 - Kept by the operator for at least two years; and
 - Made available for the regulator to examine.
- 2.3 The emission requirements and methods and frequency of monitoring set out in Table 1, in Schedule 1, shall be complied with. Sampling shall be representative.
- 2.4 Any monitoring display required for compliance with the permit shall be visible to operating staff at all times. Corrective action shall be taken immediately if any periodic monitoring results exceed a limit in table 1, or if there is a malfunction or breakdown of any equipment which might increase emissions. Monitoring shall be undertaken or repeated as soon as possible thereafter and a brief record shall be kept of the main actions taken.
- 2.5 All plant and equipment capable of causing, or preventing, emission and all monitoring devices shall be calibrated and maintained in accordance with a Suitable Maintenance Regime. Records shall be kept on such maintenance.

Section 3 - Silos

- 3.1 Bulk cement and cementitious materials shall only be stored inside the silos.
- 3.2 Dust emissions from loading or unloading road tankers shall be minimised by venting to reverse jet filters or back venting to a delivery tanker fitted with an on-board, truck- mounted relief valve and filtration system and by connecting transfer lines first to the delivery inlet point and then to the tanker discharge point, and by ensuring delivery is at a rate which does not pressurise the silos.

- 3.3 Silos and bulk containers of dusty materials shall not be overfilled and shall be fitted with an overfilling alarm.
 - 3.4 Displaced air from pneumatic transfer shall pass through filters prior to emission to air.
 - 3.5 Bulk storage tanks and silos containing dry material shall each be equipped with an audible and/or visible high level alarm, or volume indicator, to warn of overfilling. The correct operation of such alarms shall be checked in accordance with manufacturer's instructions. If manufacturer's instructions do not specify, then the check shall be weekly or before a delivery takes place, whichever is the longer interval.

When loading silos, deliveries must automatically stop when over filling or over-pressurisation is identified.

- 3.6 If emissions of particulate matter are visible from ducting, pipe work, the pressure relief device or dust arrestment plant during silo filling, the operation shall cease; the cause of the problem shall be rectified prior to further deliveries taking place. Tanker drivers shall be informed of the correct procedure to be followed.
- 3.7 Seating of pressure relief devices on silos shall be checked at least once a week, or before a delivery takes place, which ever is the longer interval.
- 3.8 Immediately it appears that the pressure relief device has become unseated during silo filling, no further delivery shall take place until corrective action has been taken. The pressure relief device shall be examined to check for defects before being reset and a replacement fitted if necessary. Tanker drivers shall be informed of the correct procedure to follow.

Section 4- Aggregates Delivery and Storage

- 4.1 Dusty materials, including dusty waste, shall only be stored within a 3 sided storage bays and shall be subject to suppression and management techniques to minimise dust emissions.
- 4.2 The operator shall ensure that the storage bays are never overfilled. Spillages of aggregates outside these areas shall be cleared immediately.
- 4.3 When the capacity of the storage bays is not sufficient to contain materials, excess material shall be stored in appropriate locations and covered with sheets to prevent dust emissions.

Section 5- Belt Conveying

- 5.1 The aggregate feed conveyor shall be totally enclosed to reduce wind whipping of dust. (wind boards on the sides and netting across the top.)

- 5.2 Conveyors shall be fitted with effective means of keeping the return belt clean and for collecting materials removed by the cleaning operation.

Section 6- Loading, Unloading and Transport

- 6.1 No potential dusty materials including waste or finished products shall arrive on or leave the site other than by use of sheeting or water suppression to prevent airborne emissions of dust.
- 6.2 Truck mixers shall be loaded in such a way as to minimise airborne dust emissions, for example by loading with wet pre-mixed materials. If they are loaded with dry minerals, local dust control measures shall be provided.

Section 7- Roadways and Transportation

- 7.1 All areas where there is regular movement of vehicles shall have a consolidated surface capable of being cleaned, and these surfaces shall be kept clean and in good repair.
- 7.2 Vehicles shall not track materials from the site onto the highway.

Section 8- Techniques to Control Fugitive Emissions

- 8.1 The fabric of any process buildings shall be maintained so as to minimise visible dust emissions.

Section 9- Records and Training

- 9.1 Written or computer records of all tests and monitoring shall be kept by the operator for at least **2 years**. They shall be made available for examination by the regulator. Records shall be kept of all operator inspections, including those for visible emissions.
- 9.2 All staff whose functions could impact on air emissions from the activity shall receive appropriate training on those functions. This shall include:
- Awareness of their responsibilities under the permit;
 - Steps that are necessary to minimise emissions during start-up and shutdown;
 - Actions to take when there are abnormal conditions, or accidents or spillages that could, if not controlled, result in emissions.
- 9.3 The operator shall maintain a statement of training requirements for each post with the above mentioned functions and keep a record of the training received by each person. These documents shall be made available to the regulator on request.

Section 10- Best Available Techniques

10.1 The best available techniques shall be used to prevent or, where that is not practicable reduce emission from the installation in relation to any aspect of the operation of the installation which is not regulated by any other condition of this permit.

END OF CONDITIONS.

Please Note

Where complaint is attributable to the operation of the installation and is, in the opinion of the Local Authority, justified, or if new knowledge develops on the potential for harmful effects from emissions, an immediate review of the Permit shall be undertaken. The Local Authority shall subsequently specify any new requirements and compliance time scales.

An annual subsistence fee as prescribed by the Secretary of State for the Environment shall be payable, for this Permit, by the process Operator, to this Authority within 2 weeks of the 1st April of each year.

In the event that the Permit has been issued after the 1st April in the initial year then the subsistence fee shall be pro rata for the complete months remaining and shall be due within 2 weeks of the Permit issue date.

If the relevant payment is not received by Sheffield City Council's Environmental Protection Service then Permit revocation procedures shall be initiated.


