

Introduction

This booklet lists sources available within Sheffield Libraries Archives and Information for the study of the Hillsborough Football Disaster of 1989.

It is not a detailed account of the tragedy; it merely points the reader who wishes to carry out their own research to what is available within Sheffield Libraries and Archives.

Much of the material listed in this *Guide* is open to public inspection and can be accessed within a few minutes of being requested in the Library or Archives reading room. However, some of the official records, such as those from the police and the coroner, can only be accessed with their permission. Hillsborough Stadium Football Disaster, 15 April 1989

At the FA Cup semi final between Liverpool and Nottingham Forest which was held at Sheffield Wednesday's Hillsborough Stadium on 15 April 1989 a tragedy unfolded that involved the death of many Liverpool supporters.

As the kick-off time approached there was an increasing crush outside the Leppings Lane turnstiles. To avoid injury, the police decided to open an exit gate to let more fans into the stadium. This resulted in a major influx of fans into an already crowded part of the ground, causing many to be crushed against security and crush barriers on the terraces in the West Stand. 96 of them died from their injuries.

An inquiry, chaired by Lord Justice Taylor, published its findings (known as the Taylor report) in August 1989 and January 1990. It outlined the events of that day and made a number of recommendations on football stadium design.

In the immediate aftermath of the tragedy there was considerable controversy over the way some newspapers reported the events and also in the conduct of the South Yorkshire Police and other agencies. This controversy is represented in the resources listed in this Guide.

The memories of that tragic day are still raw and the controversy about who was responsible continues. During the two decades that have passed a large amount of material has been published or otherwise made available. This *Guide* provides a detailed list of much of that information.

Aug 1990	Director of Public Prosecutions decides not to bring any criminal charges against any individual or organisation.
28 Mar 1991	Inquest into the deaths at the stadium returns a verdict of accidental death.
4 Oct 1991	Memorial at Sefton (Merseyside) unveiled.
1992	Six families applied for a Judicial review of the Coroner's inquests.
Mar 1993	96 th victim, Tony Bland died.
Nov 1993	Judicial review of inquests was dismissed.
1996	Granada TV produced a television drama, entitled 'Hillsborough'.
Feb 1998	Lord Justice Stuart-Smith reports on his scrutiny of the Hillsborough evidence. Home Secretary announced there would be no new public inquiry.
1999	Permanent memorial erected at Hillsborough Stadium.
2000	Prosecutions at Leeds Crown Court of Chief Superintendent Duckenfield and Superintendent Murray end with Murray not guilty and no verdict reached on Duckenfield.
2012	Hillsborough Independent Panel report on the disclosure of documents published.
19 Dec 2012	High Court quashed original Coroner's Inquest verdict of accidental death.
