Section 14(1) of the Road Traffic Regulation Act 1984 (RTRA 1984) and Regulation 3 of the Road Traffic (Temporary Restrictions) Procedure Regulations 1992 (SI 1992/1215)

FURNIVAL GATE (TEMPORARY BUS GATE) ORDER 2020 ("the Order")

- 1. Sheffield City Council gives notice that it proposes to make the Order under section 14(1) of the RTRA 1984 and any other enabling powers over an area of the highway named Furnival Gate.
- 2. The Order is needed because of the likelihood of danger to the public and for purposes connected to coronavirus.
- 3. If the Order is made, the Order shall come into operation on 9 September 2020 and shall remain in force for a period of 18 months. The duration of the Order can be extended with the approval of the Secretary of State for Transport. The restriction specified will only have effect at such times and to such extent as indicated by the display of notices.
- 4. While the Order is in operation it will suspend the provisions of THE SHEFFIELD CITY COUNCIL (CHARTER SQUARE) (PROHIBITION OF DRIVING AND PROHIBITED/PRESCRIBED TURNS) ORDER 2016 but only insofar as the following:
 - Every person causing or permitting a vehicle to proceed in a south easterly direction on Furnival Gate shall on reaching the junction with Pinstone Street make a left turn in to that road.
- 5. The Order shall prohibit any person from causing or permitting a vehicle to proceed in a south easterly direction on Furnival Gate beyond the junction with Pinstone Street unless that vehicle is;
 - A service bus, works bus, pedal cycle or taxi;
 - Proceeding upon the direction or with the permission of a police constable in uniform or a traffic warden:
 - Being used for the removal of any obstruction to traffic;
 - Being used in an emergency for police, fire brigade or ambulance purposes;
 - Being used by the local authority for enforcement purposes;
 - Being used for the laying, erection, alteration or repair of any sewer, or of any main, pipe or apparatus for the supply of gas, water, electricity, or of any telecommunications apparatus as defined in the Telecommunications Act 1984.

Any vehicle shall not permitted to continue beyond the junction with Pinstone Street shall instead make a left turn into Pinstone Street.

'Pedal Cycle' means a pedal bicycle or pedal tricycle not being in either case a mechanically propelled vehicle.

'Service Bus' means a public service vehicle being used in the provision of a local service within the meaning of the Transport Act 1985 or a public service vehicle being used to carry passengers for hire and reward at separate fares other than are being used under the conditions set out in Part IV of Schedule 1 to the Public Passenger Vehicles Act 1981.

'Works Bus' means a vehicle which is constructed or adapted to carry 12 or more passengers and which has been provided by an employer for the purpose of carrying persons employed by them or on their behalf to or from their place of employment and is being used for such purpose.

'Taxi' means a Hackney Carriage or a Private Hire Vehicle operating under a license issued by a Local Authority.
