THE SHEFFIELD CITY COUNCIL (HEELEY) (20 MPH SPEED LIMIT) ORDER 2022

NOTICE IS HEREBY GIVEN that Sheffield City Council proposes to make an Order under the provisions of Section 84 and Schedule 9 of the Road Traffic Regulation Act 1984

The effect of the Order will be to introduce a 20mph speed limit on the whole or parts of Alexandra Road, Anns Road, Anns Road North, Bradwell Street, Cross Myrtle Road, Delf Street, Heeley Bank Road, Midhill Crescent, Midhill Road, Moffatt Road, Myrtle Road, Olive Grove Road, Richards Road, Slate Street, Spurr Street and St Elizabeth Close.

(HEELEY) (20 MPH SPEED LIMIT) ORDER 2022

The Sheffield City Council in exercise of its powers under Section 84 having given public notice in accordance with subsection (2) of that section and schedule 9 of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby makes the following Order:-

1. No person shall drive any vehicle at a speed exceeding 20 miles per hour on any lengths of road specified in the Schedule to this Order.
2. No speed limit imposed by this order applies to vehicles falling within regulation 3(4) of the Road Traffic Exemptions (Special Forces) Variation and Amendment) Regulations 2011 when use in accordance with regulation 3(5) of those regulations.
3. This Order shall come into operation on the day of and may be cited as The Sheffield City Council (Heeley) (20 MPH Speed Limit) Order 2021.

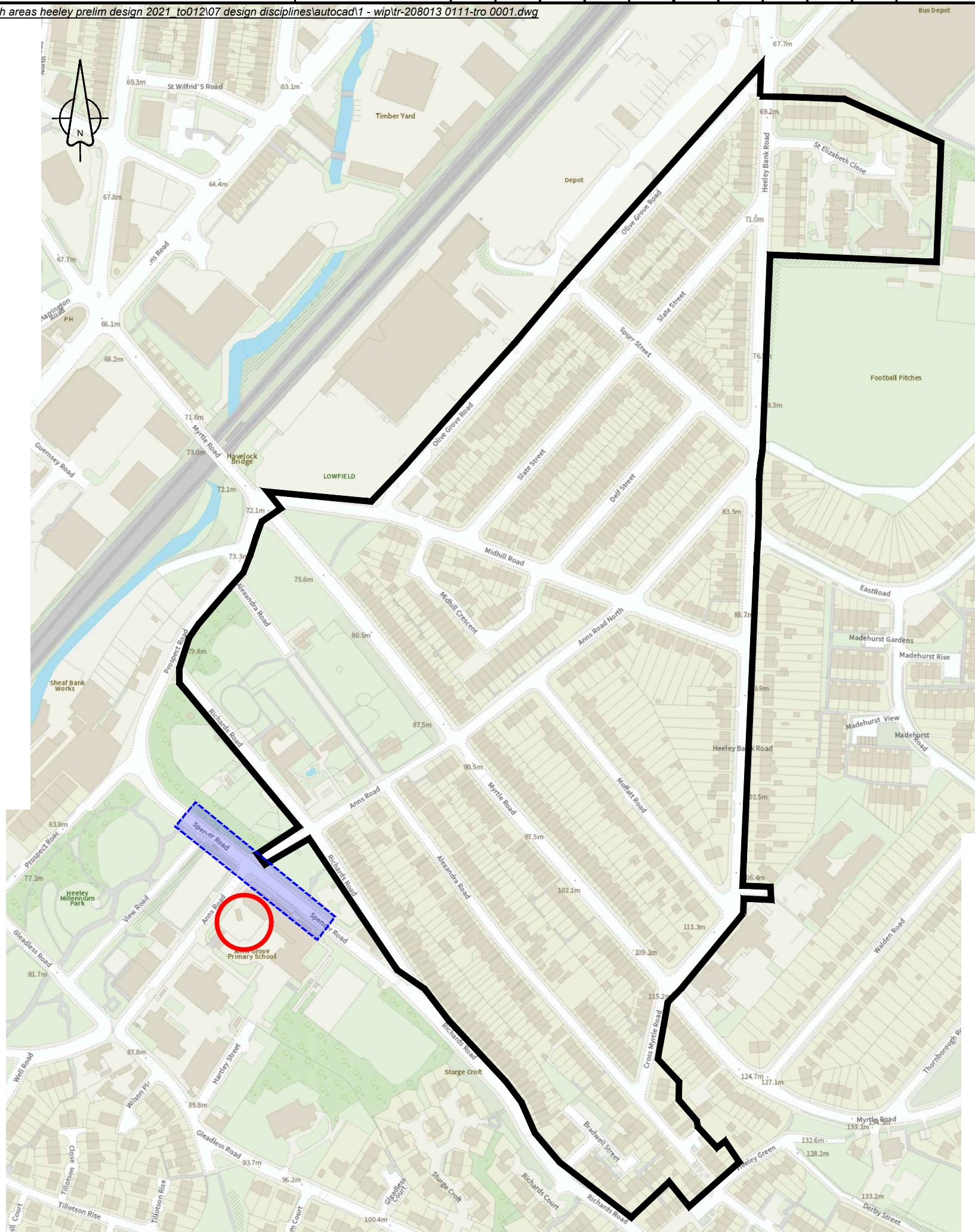

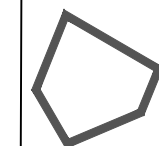
STATEMENT OF REASONS

The proposed 20mph speed limit is required to control vehicle speeds in the residential streets of the Heeley area.

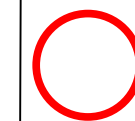
