NOTICE IS HEREBY GIVEN that on the 13th day of January, 2022 the Sheffield City Council made the above Orders which comes into operation on the day of 14th January, 2022 under the provisions of the Road Traffic Regulation Act 1984.

The effect of the Orders will be to remove the 20mph Speed Limit on Johnson Lane and Prohibited Access on Johnson Lane.

Any person who wishes to question the validity of the Order or any of its provisions on the grounds that it is not within the powers of the enabling Act or that a requirement of the enabling Act or any of the relevant regulations made thereunder has not been complied with may, within six weeks of the 14th January, 2022 make application for that purpose to the High Court.

The Sheffield City Council in exercise of its powers under Section 1(1), 2(1) and (2) and Schedule 9 of the Road Traffic Regulation Act 1984 (“the Act”) and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby makes the following Order:-

1. The Sheffield City Council (Various Roads, Central Area) (Prohibition of Driving, Prescribed Turns and Prohibited Turns) Order 1992 (as amended) shall have effect as though in the Schedule 1D thereto the item ‘6 Johnson Lane’ was deleted.

2. This Order shall come into operation on the 14th day of January, 2022 and may be cited as The Sheffield City Council (Various Roads, Central Area) (Prohibition of Driving, Prescribed Turns and Prohibited Turns) Order 1992 (Amendment No. 26) Order 2022.
