Sheffield's Troubled Families Outcome Plan

Introduction

The Troubled Families programme aims to develop and embed a culture of whole family, partnership working across support services nationally in order to better support families to overcome multiple and complex needs and achieve significant and lasting change in their lives.

In Sheffield, we term this approach the Building Successful Families (BSF) programme. Our successful track record in the first phase of the programme, achieving 100% success in "turning around" the lives of 1680 families, and our ongoing achievement and ambition in the Expanded Phase contributed to our award of Earned Autonomy. This changes our funding model and places more emphasis on the achievement of our service transformation goals. Our ambition is not only to transform the lives of identified families but to transform our services to be kinder, more integrated and more sustainable.

Our success in this programme is based on our achievement of significant outcomes for 5360 families and our progress towards our Earned Autonomy objectives. These objectives reflect our ambition across our services to tackle some of our city's key challenges connected to the programme's aims across the life course.

Our Troubled Families Outcome Plan (TFOP) defines how we identify families for the programme, what successful family outcomes look like and our Earned Autonomy objectives. We used the Financial Framework developed by DCLG and local partner workshops to define our TFOP and we review and update it every year to ensure it reflects the approaches taken in the city and any changes we have made.

Timeline Targets for success¹

Operational Managers within services will be key to monitoring the progress made with families against success criteria. The Performance & Analysis Service (PAS) will oversee data collation and analysis in order to meet a range of governmental reporting requirements: reports will also be generated in order to inform local service design.

As part of our commitment to the national programme, we continue to contribute to the evaluation and provide data back to MHCLG². We continue to work towards achieving 100% success with 5360 families by the end of the programme, as set out in the below targets³:

Identification of Families

To qualify for attachment to the BSF programme, families must meet at least 2 of the Headline Problems. These Headline Problems are how the Troubled Families unit defines overarching "baskets" of indicators that suggest areas of need and support. They are, in essence, a way of grouping issues into overarching themes. The Headline Problems are:

- 1. Crime or Anti-Social Behaviour;
- 2. Education;
- 3. Child who needs help;
- 4. Financial Exclusion & Homelessness;
- 5. Domestic Violence & Abuse;
- 6. Health.

Families can meet multiple Issues under any of the Headline Problems but only if they are across at least 2 Headline Problems. Qualifying Headline Problems must be met by more than one family member.

In addition, all cases that are attached to the programme must be able to prove that there has been:

- A whole family keyworker;
- A whole family action plan;
- A whole family assessment;

• A whole family review process.

Financial exclusion & homelessness	Adult is in receipt of out of work benefits or claiming Universal Credit and subject to work-related conditions, Young person is/at risk of being NEET, Family is/at risk of financial exclusion (e.g. at risk of eviction, in rent arrears, claiming income support, relying on food banks, claims to Financial Assistance schemes, receiving debt support, fuel poverty, unmanageable debt), Child/family is/has been at risk of becoming homeless, is experiencing poor housing conditions, Asylum seeking family or with no leave to remain
Domestic Violence & Abuse	Adult/child has experienced, is currently experiencing or is at risk of experiencing Domestic Violence or Abuse (keyworker (through DASH) or family identified) or is known to have perpetrated Domestic Violence or Abuse
Health	Adult or child with mental health issues or suspected or actual self-harm, drug or alcohol issues, physical health need that is impacting on family functioning, not accessing or failure to access appropriately universal health support, Teen pregnancy or child's/young person's sexual activity, Child/Adult has identified learning or development need/disability or Adult with caring responsibilities for another adult that is impacting on family functioning

Achieving Family Outcomes

Families will be supported to achieve significant changes in their lifestyle/circumstances and monitored longitudinally (via data reporting) to track whether or not this progress is sustained for a period of 6 months.

If successful we will see families who are:

- more resilient to deal with crises (fewer referrals to key agencies);
- better able to retain tenancies (fewer evictions & house moves);
- able to acknowledge importance of and engage with the early years & education system (increase in attendance, reduction in exclusions, children who are school ready)
- able to engage in employment (reduction in out of work benefit costs);
- better neighbours and community citizens (reduction in low level ASB/crime),
- able to act appropriately to ensure the safety of children living with them (reduced escalation to Social Care or crisis services);
- safer (reduction in Domestic Violence/Abuse);
- healthier (reduction in substance misuse, improved mental wellbeing, reduced childhood obesity).

Ultimately we will see children, young people and families who have stable home environments, are healthy, safe from harm and have aspirations for their future.

Our outcomes framework recognises levels of success for families: it's ambitious but understands that success looks different for all the families we support, particularly those that have high levels of need and complexity. Our framework is designed to encourage all services to work towards whole family working for all families, as well as sustainable family outcomes that are meaningful for them and recognisable for their families.

The framework sees success as either an adult that has been out of work is in continuous employment for a period of 26 weeks/13 weeks depending on benefit claimed or family outcomes (as outlined below) are achieved. The table below details the expected key success criteria by headline problem. For Child who needs help the success criteria is on a sliding scale from top to bottom dependent on the initial level of unmet need.
